THE EDUCATION (CURRICULUM) ORDER 2011

Coming into operation

1st October 2011

The Department of Education and Children makes this order under section 8(1) of the Education Act 2001¹, and after consulting such organisations representative of teachers, and such other persons and bodies, as that Department considers appropriate, the following Order is hereby made:—

1. **Citation and commencement**

This Order may be cited as the Education (Curriculum) Order 2011 and shall come into operation on the 1st October 2011.

2. **Prescribed curriculum**

The curriculum for all registered pupils at provided schools and maintained schools shall be that specified in the Schedule.

3. Revocation

The Education (Curriculum)(No 2) Order 2004² is revoked.

SCHEDULE

PRESCRIBED CURRICULUM

General principles

- 1. (1) The following principles shall apply to the curriculum for all pupils of compulsory school age:-
 - (a) all pupils shall follow a broad and balanced curriculum which shall be constructed in a manner which reflects current Isle of Man curriculum quidance;
 - (b) any choices available within the curriculum should be both clear and explicit so that decisions are made with the informed consent of parents and (where appropriate) pupils;
 - (c) where appropriate, the content of all subjects shall include references to Manx culture and history;
 - (d) all teaching shall promote the personal spiritual, moral, social and cultural development of pupils and contribute to their education in the fields of
 - (i) health;
 - (ii) careers;
 - (iii) citizenship;
 - (iv) numeracy and literacy; and
 - (v) thinking skills and creativity;
 - (e) religious education shall be given in accordance with section 12 of the Act.
- (2) For the avoidance of doubt, in this Schedule "Manx culture" includes Manx Gaelic.

Pupils aged up to 5 years (Foundation Stage)

- 2. The curriculum for pupils aged up to 5 years in schools shall include
 - (a) personal, social and emotional development;
 - (b) communication, language and literacy;
 - (c) mathematical development;
 - (d) knowledge and understanding of the world;
 - (e) physical development; and
 - (f) creative development.

Pupils aged from 5 to 14 years (Key Stages 1, 2 and 3)

- 3. (1) The curriculum for pupils aged from 5 to 14 years shall include
 - (a) English;
 - (b) mathematics;
 - (c) science;
 - (d) religious education;
 - (e) physical education;
 - (f) design technology;
 - (g) information and communication technology;

- (h) history;
- (i) geography;
- (j) art and design;
- (k) music; and
- (I) Manx culture and history (which may be taught through other subjects).
- (2) In the case of pupils aged 7 to 11 years (Key Stage 2), the curriculum may include
 - (a) French; and
 - (b) as an option, Manx Gaelic.
- (3) The curriculum for pupils aged from 11 to 14 years (Key Stage 3) shall include
 - (a) French;
 - (b) citizenship; and
 - (c) as an option, Manx Gaelic.

Pupils aged from 14 to 16 years (Key Stage 4)

- 4. (1) The following principles shall apply to the curriculum for all pupils aged from 14 to 16 years:—
 - (a) all courses shall lead to a recognised external accreditation at the highest level achievable by the pupil, wherever this is available and appropriate;
 - (b) subject to paragraph (1)(a), there shall be a degree of choice of subjects, and pupils shall be encouraged to follow courses of study which will best allow them to achieve success and meet their aspirations;
 - (c) the curriculum shall be relevant to the world of work and, for some pupils, may be explicitly so through specially designed programmes of study.
 - (2) The curriculum for pupils aged from 14 to 16 years shall include —
 - (a) English;
 - (b) mathematics;
 - (c) science (single or dual award or 3 separate sciences);
 - (d) religious education;
 - (e) physical education; and
 - (f) Manx culture and history (which may be taught through other subjects).
- (3) In addition a range of other subject options shall be available to all pupils aged from 14 to 16 years, which shall include -
 - (a) a modern foreign language;
 - (b) a humanities course (one or more of
 - (i) history,
 - (ii) geography,
 - (iii) economics, and
 - (iv) politics);
 - (c) information and communication technology (which may be taught through other subjects);

- (d) design technology;
- (e) art and design;
- (f) music;
- (g) Manx Gaelic; and
- (h) vocational options.
- . (4) No subject option which does not lead to a recognised external accreditation shall be offered without the prior approval of the governors of the school.
