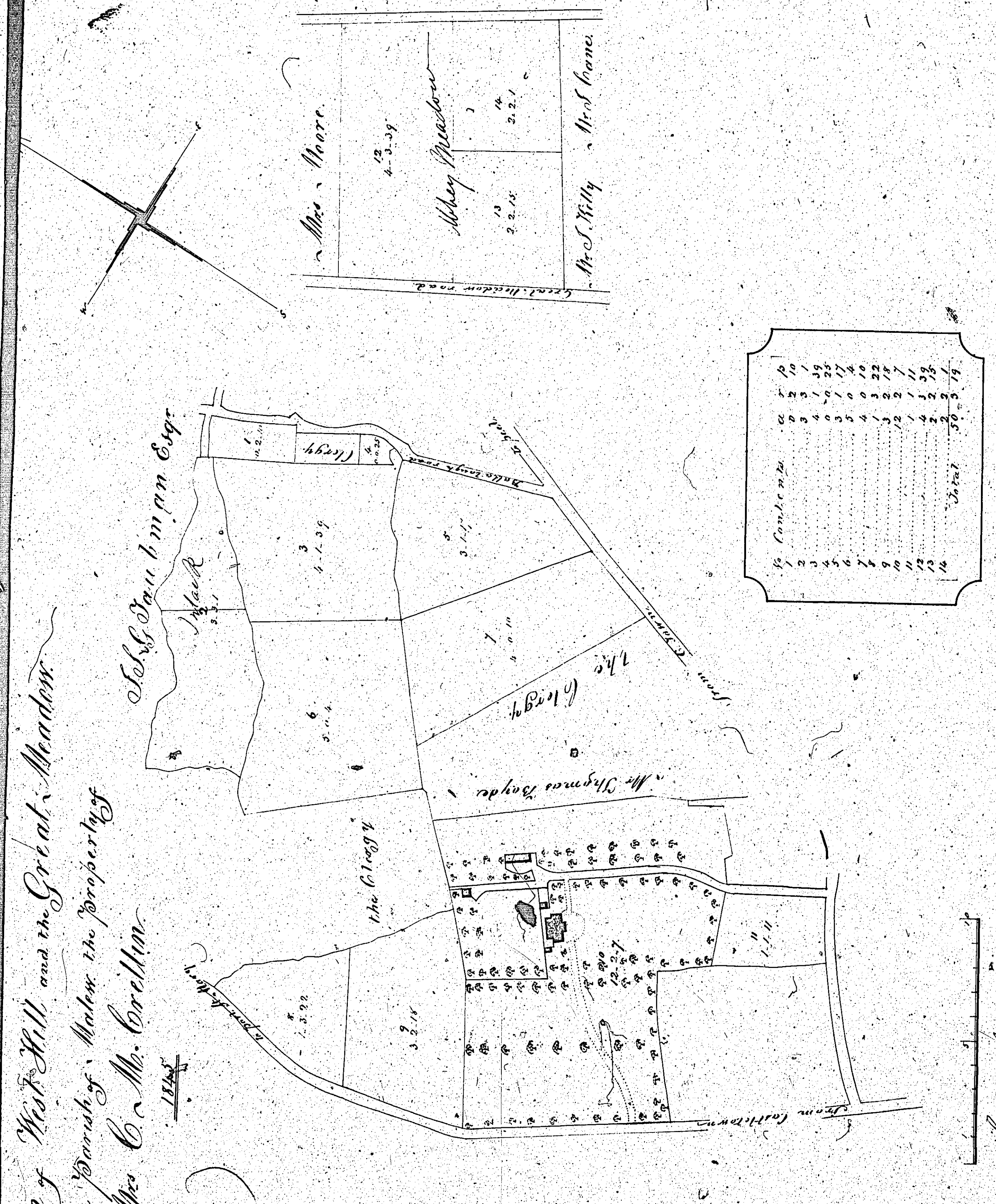
Plan of West Hill and the Great Meadow
