# IMMIGRATION (FEES) (NO.2) (AMENDMENT) (NO.2) REGULATIONS 2020

*Laid before Tynwald: 15 December 2020*

*Coming into Operation: in accordance with regulation 2*

The Minister for the Cabinet Office makes the following Regulations with the consent of Treasury under sections 68(1), and (7) to (10) of the Immigration Act 2014<sup>1</sup> as that Act has effect in the Island<sup>2</sup>.

## **1 Title**

These Regulations are the Immigration (Fees) (No.2) (Amendment) (No.2) Regulations 2020.

## **2 Commencement**

- (1) Regulations 3(1) to (3) and (5) come into operation at 11.00pm on 31<sup>st</sup> December 2020.
- (2) Regulation 3(4) comes into operation on 31<sup>st</sup> January 2021.

## **3 Amendment of the Immigration (Fees) (No.2) Regulations 2020**

- (1) The Immigration (Fees) (No.2) Regulations 2020<sup>3</sup> are amended as follows.
- (2) In regulation 3, omit the definition of “EC Association Agreement with Turkey”.
- (3) In Schedule 1, in Table 2 (exceptions in respect of fees for leave to enter the Isle of Man) —
  - (a) in 2.1 in the heading, for “the EC Association Agreement with Turkey” substitute “Appendix ECAA Extension of Stay to the immigration rules<sup>4</sup>”;

- (b) in 2.1.1 in the second column for “the terms of the EC Association Agreement with Turkey” substitute “Appendix ECAA Extension of Stay to the immigration rules”.

- (4) In Schedule 2, in Table 3 after 3.5.3 insert –

<b>3.6</b>	<b>Fees for applications for limited leave to remain in the Isle of Man under Appendix Hong Kong British National (Overseas) to the immigration rules, other than as a specified dependant</b>	
3.6.1	Application for limited leave to remain in the Isle of Man for a period of thirty months under Appendix Hong Kong British National (Overseas) to the immigration rules, other than as— (a) a dependant partner on the BN(O) Status Holder route or the BN(O) Household Member route under that Appendix, (b) a BN(O) Household Child or BN(O) Adult Dependant Relative (within the meaning those expressions have in that Appendix) on the BN(O) Status Holder route under that Appendix, or (c) a dependant child on the BN(O) Household Member route under that Appendix.	£180
3.6.2	Application for limited leave to remain in the Isle of Man for a period of five years under Appendix Hong Kong British National (Overseas) to the immigration rules, other than as— (a) a dependant partner on the BN(O) Status Holder route or the BN(O) Household Member route under that Appendix, (b) a BN(O) Household Child or BN(O) Adult Dependant Relative (within the meaning those expressions have in that Appendix) on the BN(O) Status Holder route under that Appendix, or (c) a dependant child on the BN(O) Household Member route under that Appendix.	£250

- (5) In Schedule 2, in Table 6 (exceptions in respect of fees for applications for, or in connection with, leave to remain in the Isle of Man) —
- (a) in 6.4 in the heading, for “the EC Association Agreement with Turkey” substitute “Appendix ECAA Extension of Stay to the immigration rules”;
- (b) in 6.4.1 in the second column for “the terms of the EC Association Agreement with Turkey” substitute “Appendix ECAA Extension of Stay to the immigration rules”.

*EXPLANATORY NOTE**(This note is not part of the Regulations)*

These Regulations amend the Immigration (Fees) (No.2) Regulations 2020 (“the 2020 Regulations”).

Regulation 3(2), (3) and (5) replaces and removes existing fee exceptions in connection with applications made, and leave granted, under the terms of the agreement establishing an Association between the European Community and Turkey signed at Ankara on 12th September 1963 (the EC Association Agreement with Turkey).

In connection with the withdrawal of the United Kingdom from the European Union, the new Appendix ECAA Extension of Stay to the Isle of Man immigration rules makes provision for applications by certain Turkish businesspersons and their dependants. It enables holders of existing leave granted under the EC Association Agreement with Turkey to apply for an extension, and also provides for applications by dependants of such persons.

These fee exceptions are amended, with effect from 11pm on 31<sup>st</sup> December 2020, to apply to applications under new Appendix ECAA Extension of Stay in the Isle of Man immigration rules, rather than under the terms of the EC Association Agreement with Turkey.

Regulation 3(4) sets fees for applications for limited leave to remain in the Isle of Man under new Appendix Hong Kong British National (Overseas) to the Isle of Man immigration rules.
