6.	Consultation on proposed coastal footpath legislation	
	FW asked for any thoughts/suggestions. DL commented could be political issues with regard to certain locations such as Raad Ny Foillan where members of the public could wander off to the beach which may be problematic with landowners/farmers. FW looking at access for public to coastal areas and aware there are some private beaches. SM asked to take high waters into consideration and SG also to be ECO friendly i.e. nesting season etc. Timescale for this consultation is early New Year.  Discussions on legislation i.e. Agricultural land, SC commented not a lot of room	
	for animal control and need to engage on the potential risk. Minister reminded group this is not a referendum it is a consultation to get the legislation. SC commented the need to handle sensitivity on farms and better education for public to use footpaths and move to safer places.	
	SG commented on the amount of ramblers with dogs that are not kept on leads and DL agreed and witnessed many irresponsible dog owners. FW to look at putting something on PROW and suggested it could also fall under the ECCC.	
	On legislation DL believes there could be strong objection on Raad Ny Foillan and will need to be honest. Minister informed the group there is no political agenda in this consultation and FW is looking at first consultation in 8 weeks' time and legislation by 2025.	
7.	CAG minutes and website	
	It was agreed FW to put CAG minutes on to website and DL asked the minutes of meetings to be distributed within 2 weeks of the meeting. All names to be changed to either title or representation.

	JW commented that he had seen on social media Sky Hill track closed and FW to action.
