IMMIGRATION (FEES) (NO.2) (AMENDMENT) ORDER 2024

*Laid before Tynwald:**Coming into Operation**6 April 2024*

The Minister for the Treasury makes the following Order under section 68(1) to (6), (12) and (13) of the Immigration Act 2014 (of Parliament)¹ as that Act has effect in the Island².

1 Title

This Order is the Immigration (Fees) (No.2) (Amendment) Order 2024.

2 Commencement

This Order comes into operation on the 6 April 2024³.

3 Amendment of the Immigration (Fees) (No.2) Order 2020

(1) The Immigration (Fees) (No.2) Order 2020⁴ is amended as follows.

(2) In article 3 (interpretation) —

(a) in the relevant places in the alphabetical list insert —

☒ “**certificate of sponsorship**” has the same meaning as in rule 6 (interpretation) of the immigration rules;☒; and

☒ “**confirmation of employment**” has the same meaning as in Appendix W (immigration rules for workers) of the immigration rules;☒;

(b) in the definition of “sponsored worker” at the end, insert ☒ or confirmation of employment☒; and

- (c) in the definition of “unsponsored worker” at the end, insert ~~“or confirmation of employment”~~.
- (3) In article 5 (applications for leave to enter or leave to remain in the Isle of Man), in Table 1 —
- (a) in row 1.2 omit “, where a certificate of sponsorship has been issued”; and
 - (b) in the third column (maximum amount) in —
 - (i) row 1.1, for “£1,000” substitute ~~“£1,000”~~ **“£1,200”**;
 - (ii) row 1.2, for “£1,500” substitute ~~“£1,500”~~ **“£2,000”**;
 - (iii) row 1.4, for “£480” substitute ~~“£480”~~ **“£600”**;
 - (iv) row 1.5, for “£3,250” substitute ~~“£3,250”~~ **“£3,600”**; and
 - (v) row 1.7, for “£3,250” substitute ~~“£3,250”~~ **“£3,600”**.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Immigration (Fees) (No.2) Order 2020 (SD No. 2020/0141) to increase the maximum fee amounts that can be charged for certain services connected with immigration, primarily for applications for leave to enter or leave to remain in the Isle of Man.

This Order maintains the Island's alignment with the UK's immigration fees.

This Order also includes additions and modifications to Article 3 (interpretation) to clarify the definition of sponsored worker and align relevant definitions to the Immigration Rules.
