## **CIVIL PARTNERSHIP (FEES) ORDER 2023**

Approved by Tynwald: 22nd November 2023 Coming into operation in accordance with article 2

The Treasury makes the following Order under section 32(1) and (2) of the Civil Partnership Act 2011.

#### 1 Title

This Order is the Civil Partnership (Fees) Order 2023.

#### 2 Commencement

If approved by Tynwald, this Order comes into operation on 1 April 2024<sup>1</sup>.

### 3 Fees

- (1) The fees payable under section 32(1) of the Civil Partnership Act 2011 are prescribed in the table in Schedule 1 as follows
  - (a) column 1 specifies the provision of the Civil Partnership Act 2011 under which a matter arises for which a fee is payable;
  - (b) column 2 specifies the matter in respect of which a fee is payable; and
  - (c) column 3 prescribes the fee in respect of the matter described in the corresponding row in column 2.
- (2) The fees payable under section 32(2) of the Civil Partnership Act 2011<sup>2</sup> are prescribed in the table in Schedule 2 as follows
  - (a) column 1 specifies the provision of the Civil Partnership (Conversion to Marriage) Regulations 2016 under which a matter arises for which a fee is payable;

- (b) column 2 specifies the matter in respect of which a fee is payable; and
- (c) column 3 prescribes the fee in respect of the matter described in the corresponding row in column 2.

The Civil Partnership (Conversion to Marriage) Fees Order 2016<sup>3</sup> and the Civil Partnership (Fees) Order 2016<sup>4</sup> are revoked.

This Order revokes the Civil Partnership (Fees) Order 2016 and the Civil Partnership (Conversion to Marriage) Fees Order 2016.
