## **SOCIAL SECURITY (CHILE) (CONVENTION) ORDER 2015**

*Approved by Tynwald:* 16 June 2015  
*Coming into Operation:* 19 June 2015

The Governor in Council makes the following Order under section 179 of the Social Security Administration Act 1992 (of Parliament) as that Act has effect in the Isle of Man<sup>1</sup>.

### **1 Title**

This Order is the Social Security (Chile) (Convention) Order 2015.

### **2 Commencement**

If approved by Tynwald<sup>2</sup>, this Order comes into operation on 19 June 2015 and has effect from 1 June 2015.

### **3 Modification of the benefit Acts**

(1) The benefit Acts shall be modified to such extent as may be required to give effect to the provisions contained in the reciprocal agreement, so far as they relate to the Isle of Man.

(2) In this Article –

the benefit Acts means the Social Security Administration Act 1992, the Social Security Contributions and Benefits Act 1992 and the Social Security (Consequential Provisions) Act 1992 (Acts of Parliament), as they have effect in the Isle of Man<sup>3</sup>;

the reciprocal agreement<sup>4</sup> means the Convention on Social Security between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Chile (signed in Santiago on 13 March 2012), the text of which is set out in the Social Security (Contributions) (Republic of Chile) Order 2015<sup>4</sup>.
