Approved by Tynwald: 9 July 2013 Coming into Operation: 1 September 2013

The Treasury makes these Regulations under section 12 of the Company and Business Names etc Act 2012.

1 Title

These are the Company and Business Names (restricted words and phrases) Regulations 2013.

2 Commencement

If approved by Tynwald, these Regulations come into operation on 1 September 2013.

3 Interpretation

In these Regulations —

"the Act" means the Company and Business Names etc Act 2012; and

"the table" means the table specified in regulation 5.

4 Restricted words and phrases

- (1) The words and phrases specified in column 1 of the table are restricted words and phrases for the purposes of section 7(3)(f) of the Act.
- (2) A person specified in column 2 of the table is a consultee for the purposes of section 7(3)(f) of the Act in respect of the word or phrase specified in column 1 to which the entry in column 2 relates.
