PUBLIC SECTOR PENSION SCHEMES (REVOCATION) SCHEME 2013

Approved by Tynwald:

The Public Sector Pensions Authority makes the following Scheme under section 6(1)(c) of the Public Sector Pensions Act 2011.

1 Title

This Scheme is the Public Sector Pension Schemes (Revocation) Scheme 2013.

2 Commencement

If approved by Tynwald, this Scheme comes into operation on XXXXXX.

3 Interpretation

“**Former Pensioner Member**” means —

(a) a person who was immediately before the Commencement Date receiving a pension in payment from a scheme listed in rule 4 (1) in respect of his or her service with an Employing Authority; or

(b) a person who is the beneficiary of a Scheme Member and was immediately before the Implementation Date receiving a pension or allowance in payment in respect of the scheme member’s service with an Employing Authority.

“**Employing Authority**” means the employer of public sector employees or, for public sector office holders, means the person for the time being paying the remuneration of the employee.

“**Public Sector Employee**” means a person in respect of whom the Public Sector Pensions Authority may make a scheme under section 6(1)(c) of the 2011 Act.
