

# THE CHILDREN AND YOUNG PERSONS ACT 2001

### THE PARENTAL ORDERS REGULATIONS 2001

Approved by Tynwald

11th December 2001

Coming into Operation

1<sup>st</sup> January 2002

In exercise of the powers conferred on the Department of Health and Social Security by section 89(8) of the Children and Young Persons Act 2001<sup>1</sup>, and all other enabling powers, the following Regulations are hereby made:-

# 1. Citation commencement and interpretation

- (1) These Regulations may be cited as the Parental Orders Regulations 2001 and, subject to section 102(2) of the 2001 Act, shall come into operation on the 1<sup>st</sup> January 2002.
  - (2) In these Regulations -

"the 2001 Act" means the Children and Young Persons Act 2001;

"the 1984 Act" means the Adoption Act 1984<sup>2</sup>;

"parental order" means an order under section 89 of the 2001 Act (parental orders in favour of gamete donors) providing for a child to be treated in law as a child of the parties to a marriage.

## 2. Application of Adoption Act 1984 provisions to parental orders etc.

- (1) The provisions of the 1984 Act set out in column 1 of the Schedule shall have effect with the modifications (if any) set out in column 2 of the Schedule in relation to parental orders and applications for such orders, as they have effect in relation to adoption and applications for adoption orders.
- (2) In construing any provision of the 1984 Act which is modified by paragraph (1), a reference to any other provision so modified shall be taken as a reference to the latter provision as so modified.

# 3. References in 2001 Act to be read as references to parental orders etc

- (1) The reference in section 57(6)(c) of the 2001 Act to a person who proposes to adopt a child under arrangements made by an adoption agency within the meaning of the 1984 Act shall be read as including a reference to a person who proposes to be treated as the parent of a child by virtue of a parental order and the 1984 Act as applied by these Regulations.
- (2) The references in sections 86(2) and 87(5)(c) of the 2001 Act to a child who is treated by virtue of adoption as not being the child of any person other than the adopter or adopters shall be read as including references to a child who is treated by virtue of the making of a parental order as not being the child of any person other than the husband and wife as defined by section 89 of the 2001 Act.

Section 32 (property devolving with peerages etc)

Section 33 (protection of trustees and personal representatives)

Section 34 (meaning of "disposition")

(a) For "this Part" (in each place) substitute "sections 39, 42, 44, 45 and 47"; and

Section 35 (miscellaneous enactments)

(b) in section 34(2) for "applies" substitute "apply".

For subsection (1) substitute —

"(1) Section 39(2) does not apply so as to prevent a child who is the subject of a parental order from continuing to be treated as the child of a person who was in law the child's mother or father before the order was made, for the purposes of the table of kindred and affinity in Schedule 1 to the Marriage Act 1984 and of section 7 (incest) of the Sexual Offences Act 1992".

Section 38 (Adopted Children Register)

- (a) For "Adopted Children Register" (in each place, except in the second place in section 38(3)), substitute "Parental Orders Register";
- (b) in section 38(1) for "adoption orders" substitute "parental orders";
- (c) in section 38(2) for "adoption" substitute "parental order";
- (d) in section 38(2) for "adopted person" substitute "person who is the subject of the parental order";
- (e) in section 38(3) for "any person shall be entitled to search that index at any time when the General Registry is open for that purpose and to have a certified copy of any entry in the Adopted Children Register" substitute "the Chief Registrar shall cause a search to be made of that index on behalf of any person or permit that person to search that index himself, and issue to any person a certified copy of any entry in the Parental Order Register,";
- (f) in section 38(4), for "marked "Adopted"" substitute "marked "Re-registered by the Chief Registrar pursuant to the Parental Orders Regulations 2001";
- (g) in section 38(6) for "adoptions and the amendment of adoption orders" substitute "parental orders and the amendment of such orders".

Section 39(1) to (5) (disclosure of birth records of adopted children)

(a) In section 39(1), for "an adopted person" substitute "a person who is the subject of a parental order";

- (a) omit the definitions of "adoption agency", "adoption order", "adoption society", "approved adoption society", "authorised officer", "body of persons", "British adoption order", "British territory", "the Convention", "Convention adoption order", "Convention country", "internal law", "National", "overseas adoption", "place of safety", and "relative";
- (b) after the definition of "guardian" insert ""husband and wife" means, in relation to the provisions of this Act as they have effect in relation to parental orders and applications for such orders, the husband and wife as defined in section 89 of the Children and Young Persons Act 2001;"; and
- (b) after the definition of "notice" insert ""parental order" means an order under section 89 of the Children and Young Persons Act 2001;".

Schedule 2 (registration of adoptions) paragraphs 1 and 4

- (i) in paragraph 1(1) for "adoption order" substitute "parental order";

### **EXPLANATORY NOTE**

(This note is not part of the Regulations.)

These Regulations apply with modifications certain sections of the Adoption Act 1984 to give effect to the arrangements by which a parental order may be obtained under section 89 of the Children and Young Persons Act 2001. Such an order may be granted by the High Court in respect of a child who is born as a result of a surrogacy arrangement and who is the genetic child of at least one of the applicants for the parental order.

The Regulations —

- (a) apply certain adoption provisions which set out the approach to be followed in applications for parental orders;
- (b) make provision for the interpretation of certain events that may be affected by the making of such an order, including the rules of construction for instruments concerning property; and
- (c) make provision for the procedural aspects of applications under section 89, and for the registration of parental orders in a Parental Order Register to be maintained in the General Registry.
