IMMIGRATION AND NATIONALITY (SUPPLY OF INFORMATION) (SPECIFIED PERSONS) ORDER 2020

Laid before Tynwald: 17 March 2020 Coming into Operation: 31 March 2020

The Minister for the Cabinet Office, with the consent of the Lieutenant Governor, makes the following Order under section 20(5) of the Immigration and Asylum Act 1999 (of Parliament) as it has effect in the Isle of Man¹.

1 Title

This Order is the Immigration and Nationality (Supply of Information) (Specified Persons) Order 2020.

2 Commencement

This Order comes into operation on 31 March 2020.

3 Interpretation

In this Order —

"the 1999 Act" means the Immigration and Asylum Act 1999 (of Parliament) as that Act has effect in the Island;

"the Assessor" means the Assessor of Income Tax for the time being appointed under Section 105 of the Income Tax Act 1970²;

"Chief Constable" has the same meaning as is given in the Interpretation Act 2015³;

"immigration purposes" has the same meaning as is given in section 20(3) of the 1999 Act;

"nationality purposes" has the same meaning as is given in section 20(9) of the 1999 Act.

4 Supply of information to the Lieutenant Governor

The following persons are specified for the purpose of section 20(1) of the 1999 Act (supply of information etc to Minister) for nationality purposes —

- (1) the Chief Constable; and
- (2) the Assessor.

5 Supply of information to the Minister for the Cabinet Office

The following persons are specified for the purpose of section 20(1) of the 1999 Act (supply of information etc to Minister) for immigration purposes —

- (1) the Chief Constable; and
- (2) the Assessor.

6 Supply of information by the Minister for the Cabinet Office

The Minister for Enterprise is specified for the purpose of section 21(2) of the 1999 Act (supply of information by Minister) for immigration purposes.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order designates the Chief Constable and the Assessor of Income Tax as specified persons under section 20 of the Immigration and Asylum Act 1999 (as extended to the Island). Information held by a specified person may be supplied to the Minister for the Cabinet Office for immigration purposes, or the Lieutenant Governor for nationality purposes.

Section 20 does not limit the circumstances in which information may otherwise be supplied and does not authorise a supply that would contravene a restriction on the disclosure of information (however imposed).

This Order also designates the Minister for Enterprise as a specified person for immigration purposes for the purpose of section 21 of the 1999 Act (as extended to the Island). Information held by the Minister for the Cabinet Office may be disclosed to the Minister for Enterprise for immigration purposes.
