

# **Coronavirus (Covid-19)**

# Passport, Immigration and Nationality Factsheet

This document provides guidance on immigration and British passport provisions made by the Cabinet Office for individuals affected by the consequences associated with coronavirus (Covid-19).

KOLL tests with the Isle of Man college have resumed - wording has been removed saying that these are currently suspended. # **Section 1: Worker Migrants & Dependents**

This section sets out the provisions made for non-Medical and Healthcare Sector Worker Migrants and their Dependents.

Those people working in the Medical and Healthcare Sector should refer to section 2.

### 1A. Automatic Extensions have now ceased

Worker Migrant visas which expired between 15 March 2020 and 30 June 2020, were automatically extended for six months from the date of their visa's expiration date.

The automatic extension of Worker Migrant visas ceased as of 1 July 2020.

#### What does this mean?

Visas which expired up to 30 June 2020 will be valid for a further six months after the date that they were originally set to expire;

Worker Migrants and their Dependents whose visas expire on or after 1 July 2020 must now make a physical application to extend their leave.

# My work has finished and I want to return home

If you do not intend to extend your Worker Migrant visa and can demonstrate that it is impossible or impractical to travel to your home country due to restrictions on travel imposed as a direct result of the COVID-19 pandemic, then your leave will be extended by an additional 30 days from the date of its expiry. For example if your visa expires on 15 July 2020, but you are unable to return to your home country due to COVID-19 related travel restrictions and provide evidence of this, then your leave will be extended to 14 August 2020.

You **must** come to our public counter to make arrangements for an Immigration Officer to update your passport to reflect the extended leave. You will need to bring your passport and documents to show that you cannot travel home.

### 1B. Supplementary Employment

The current definition of "supplementary employment" has been modified until 16 November 2020 to allow individuals to undertake additional work providing they remain employed by their existing employer as recorded on their current Confirmation of Employment.

That modified definition reads:

**"supplementary employment"** means other employment to that recorded on the Confirmation of Employment, provided the Worker Migrant remains employed by the employer recorded on the confirmation of employment.

# 1C. Employment Changes must now be authorised as normal

The temporary ability for Worker Migrants to make changes to their employment circumstances that would normally be prohibited has now ceased.

Worker Migrants who wish to make changes to their employment circumstances must once again receive authorisation from the Immigration Service prior to making any prohibited changes to the circumstances of their employment in accordance with Part 5 of Appendix W to the Isle of Man Immigration Rules.

# **Section 2: Worker Migrants & Dependents: Medical and Healthcare**

This section applies to Worker Migrants, and their Dependents, with a Confirmation of Employment with a Standard Occupational Classification Code in the Medical and Healthcare Sector<sup>1</sup> only.

# 2A. Automatic Extension

All Worker Migrant visas in the Medical and Healthcare Sector, and their Dependents', due to expire before 31 December 2020, will be automatically extended for one year from the date of their visa's expiration date, e.g. a visa due to expire on 30 December 2020, will automatically be extended to 30 December 2021.

If you need to travel internationally or need to show a third party, your employer for example that you have valid leave, please contact the <a href="mailto:immigration@gov.im">immigration@gov.im</a> to make arrangements for your passport to be updated.

# 2B Supplementary Employment

For Worker Migrants in the Medical and Healthcare sector, the definition of "supplementary employment" is modified until 31 December 2021 removing the restriction on the type of work or hours permitted for that employment

The modified definition reads:

"supplementary employment" means other employment to that recorded on the Confirmation of Employment, provided the Worker Migrant remains employed by the employer recorded on the confirmation of employment.

# **Section 3: Visitors**

# **Isle of Man Immigration Visit Visas**

If your Isle of Man issued visit visa expired **before** 31 July 2020, it will have automatically been extended so as not to expire before 31 July 2020.

If your Isle of Man issued visit visa expires **after** 31 July 2020, but you can demonstrate that it is impossible or impractical to return to your country of residence due to restrictions on travel imposed as a direct result of the COVID-19 pandemic, then your leave will be extended by an additional 30 days from the date of its expiry. For example if your visa expires on 15 July 2020, but you are unable to return to your home country due to COVID-19 related travel restrictions and provide evidence of this, then your leave will be extended to 14 August 2020.

You **must** come to our public counter to make arrangements for an Immigration Officer to update your passport to reflect the extended leave. You will need to bring your passport and documents to show that you cannot travel home.

Please note if your visa was not granted by the Isle of Man please see Section 6.

# **Section 4: Other Isle of Man visa categories**

Automatic extensions for all other Isle of Man issued visa types ceased as of 1 July 2020.

Any person whose Isle of Man issued visa expired on or after 1 July 2020 must now make a paper application to extend their leave as normal.

If your Isle of Man issued visa is due to expire and you can demonstrate that it is impossible or impractical to travel to your home country due to restrictions on travel imposed as a direct result of the COVID-19 pandemic, then your leave will be extended by an additional 30 days from the date of its expiry. For example if your visa expires on 15 July 2020, but you are unable to return to your home country due to COVID-19 related travel restrictions and provide evidence of this, then your leave will be extended to 14 August 2020.

You <u>must</u> come to our public counter to make arrangements for an Immigration Officer to update your passport to reflect the extended leave. You will need to bring your passport and documents to show that you cannot travel home.

Please note if your visa was not granted by the Isle of Man please see Section 6.

#### What must I do?

If you qualified for an automatic extension of your visa and you need to travel internationally, or need to show a third party, your employer for example that you have valid leave please come and see an Immigration Officer at our public counter to make arrangements for your passport to be updated.

If you cannot return to your home country due to COVID-19 related travel restrictions, then you **must** come to our public counter to make arrangements for an Immigration Officer to update your passport to reflect the extended leave. You will need to bring your passport and documents to show that you cannot travel home.

### **Section 5: Public Funds**

Currently all visas are subject to a condition of no recourse to public funds.

<u>The Immigration (Variation of Leave) Order 2020</u> varies the condition of no recourse to public funds where a visa holder is in receipt of public funds by virtue of the operation of:

- a) the Social Security Legislation (Benefits) (Application) (Amendment) (No. 4) Order 2020,
- b) Jobseekers Act 1995 (Application) (Amendment) Order 2020 and/or
- c) the Social Security Contributions and Benefits Act 1992 (Application) (Amendment) (No. 5) Order 2020.

This Order ceased to have effect on 7 October 2020.

# Section 6: Visas issued by UK Visas and Immigration

In very limited circumstances individuals may be in the Isle of Man in possession of a visa granted by the United Kingdom (e.g. Tier 5 Youth Mobility or a visit visa).

#### What must I do?

If you hold such a visa granted you must contact UK Visas and Immigration directly to request an extension by <u>updating your records with the Coronavirus Immigration Team</u>. This cannot be done by the Isle of Man Immigration Office.

# Section 7: Applying for Entry Clearance to the Isle of Man

Many of the UK's Visa Application Centres (VACs) operated on behalf of UK Visas and Immigration (UKVI) have now re-opened or have plans to re-open.

Please be aware that the reopening of these locations is subject to local conditions and the operating environment remaining conducive. Therefore, to ensure you always have the most up to date information on which VACs are open, please check the relevant commercial partner website.

# Section 8: Switch to a different visa whilst in the Isle of Man

As a temporary measure, holders of certain valid visas who would normally have to return to their country of normal residence, to make an application for entry clearance may apply now make that application from within the Isle of Man.

To apply you must complete a leave to remain application form found <u>here</u> for the immigration route you wish to apply for entry clearance for and send it to the address on the form.

Your application must be accompanied by your passport and all supporting documents. Applications can be paid for by telephone by either credit or debit card.

You will be able to make this application if at the date of application, there are travel restrictions in place as a direct result of the COVID-19 pandemic, which make travel to your country of ordinary residence impossible or impractical. If this is the case, you will be required to provide documentary evidence and a concise explanation setting out how travel to the country where you would normally be expected apply for entry clearance has been rendered impossible or impractical due to restrictions imposed on travel as a direct result of the COVID-19 pandemic.

Even though you are applying in the Isle of Man, your application will be assessed against the <u>entry clearance</u> requirements of the route you are applying for. If you consider the meeting of a requirement is impossible or impractical, you must set out written reasons why you believe this to be the case and submit this with your application.

An Officer may contact you for clarification of any of the above if necessary.

If your application is successful the period and conditions of leave granted to you will be the same as those that would have attached to an equivalent grant of entry clearance.

# Section 9: Isle of Man residents abroad who need to apply for a passport

If you are overseas and are unable to return to the Isle of Man before your current British passport expires, you can apply online for an <u>emergency travel document</u>. This will be issued by Her Majesty's Passport Office.

# **Eligibility**

You can apply for an emergency travel document if all the following apply:

- you're a British national this includes people residing in the Isle of Man;
- you're outside the UK;
- your British passport has been lost, stolen, damaged, is full or has recently expired;
- you do not have time to renew or replace your British passport before you travel;
- you can provide proof of your travel plans, for example booking confirmations (or detailed written travel plans if you cannot book ahead/make advance bookings).

# What an emergency travel document lets you do

An emergency travel document will allow you to travel to your destination through a maximum of 5 countries. You can also normally use it to return to the country you're applying from if you live there. Your travel plans (countries and dates) will be printed on your emergency travel document. If you change your travel plans once you have your emergency travel document, you'll need to apply and pay for a new one.

You may need a visa to leave the country you're in or to travel through other countries with your emergency travel document. Check with the embassy or consulate of each country.

Upon your arrival in the UK, Immigration Officers will keep your emergency travel document.

# Section 10: English Language Tests in the Isle of Man

There are now 2 language test providers in the Isle of Man who are approved by the Home Office.

#### International English Language Testing System (IELTS) Secure English Language Test (SELT)

This test is run by the British Council on behalf of IELTS. Tests are sat at the University College Isle of Man (UCM).

UCM have advised the tests are suspended at the moment in light of COVID-19. IELTS will update their website as soon as they are able to resume testing. Any queries should be directed to the British Council.

#### LanguageCert International ESOL SELT

This test is run by Prometric on behalf of LanguageCert. Tests are set that the University College Isle of Man (UCM).

Dates and availability are shown on the LanguageCert website here: <a href="https://selt.languagecert.org/">https://selt.languagecert.org/</a>. You will need to select **UK** as the **country** and <u>IOM</u> as the <u>town</u>. UCM advise that tests are currently available.
