Condition B is met if there are reasonable grounds for believing that the combined amount of –

- (a) the amount of the chargeable soft drinks you will produce in the next 30 days, and
- (b) the amount of prepared drink that would result from a concentrate in the next 30 days

will not exceed 1 million litres.
