TOWN AND COUNTRY PLANNING (AREA PLAN FOR THE EAST) ORDER 2020

Approved by Tynwald: 18 November 2020 Coming into operation: 1 December 2020

The Cabinet Office, by this Order, adopts the area plan known as 'The Area Plan for the East' in accordance with section 2(5) of the Town and Country Planning Act 1999.

1 Title

This Order is the Town and Country Planning (Area Plan for the East) Order 2020.

2 Commencement

If approved by Tynwald, this Order comes into operation on 1 December 2020¹.

3 Area Plan for the East

The Area Plan for the East consists of the following documents —

4 Adoption of the Area Plan

- (1) The Cabinet Office hereby adopts the Area Plan for the East.
- (2) The Area Plan for the East shall come into operation on 1 December 2020.

5 Revocation of Development Plan and Local Plans

In so far as they relate to the area covered by the Area Plan for the East, the following are revoked —

- (d) Isle of Man Planning Scheme (Braddan Parish District Local Plan) Order 1991⁵;
- (e) Isle of Man Planning Scheme (Development Plan) (Santon Head Amendment) Order 1995⁶;
- (f) Isle of Man Planning Scheme (Douglas Local Plan) Order 19987;
- (g) Isle of Man Planning Scheme (Onchan Local Plan) Order 20008; and
- (h) Laxey and Lonan Area Plan Order 20059.
