IMMIGRATION (FEES) (NO.2) (AMENDMENT) REGULATIONS 2022

Laid before Tynwald: 21 February 2023
Coming into Operation: 31 January 2023

The Minister for the Cabinet Office makes the following Regulations under 68(1), and (7) to (10) of the Immigration Act 2014¹, as that Act has effect in the Island².

1 Title

These Regulations are the Immigration (Fees) (No.2) (Amendment) Regulations 2022.

2 Commencement

These Regulations come into operation on 31 January 2023.

3 Amendment of the Immigration (Fees) (No.2) Regulations

(1) The Immigration (Fees) (No.2) Regulations 2020³ are amended as follows.

(2) In regulation 3 (Interpretation) after the definition of “the Minister” insert—

☐ **“Permission to enter”** has the same meaning as leave to enter the Isle of Man;

“Permission to stay” has the same meaning as leave to remain in the Isle of Man;☐.





EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Immigration (Fees) (No.2) Regulations 2020 ("the 2020 Regulations").

Regulations 3(2) and 3(3) insert new interpretations for "permission to enter" and "permission to stay" respectively. These terms have been introduced to the Isle of Man immigration rules and have the same meaning as leave to enter and leave to remain respectively.

Regulation 3(4) and 3(5) introduces fee exceptions so that no fees are payable for applications for permission to enter or permission to remain under Appendix U: Ukraine Scheme to the Isle of Man immigration rules.

Appendix U: Ukraine Scheme was introduced to the Island's Immigration Rules on 3rd May 2022 as a measure in the Island's response to the conflict in Ukraine. This Appendix provides for 3 routes for Ukrainian nationals and their immediate family members who are fleeing the current conflict there.

The Department has approved that applications to the Island under these Schemes will be free. The fees for applications received prior to these Regulations commencement have been waived by the Minister for Cabinet Office in accordance with regulation 11 of the 2020 Regulations. These amendments formalise this policy, and mean that applications received under the Ukraine Scheme will remain free of charge.
