# TRADE IN ANIMALS AND RELATED PRODUCTS DECLARATION OF SPECIAL MEASURES (CHRONIC WASTING DISEASE)

Made: 23 June 2023 Coming into Operation: in accordance with article 2

The Department of Environment, Food and Agriculture has reasonable grounds for suspecting the existence of chronic wasting disease in the United States of America, Canada, Republic of Korea, Norway, Sweden and Finland, such that certain animals and products originating in or dispatched from these territories are liable to pose a risk to human or animal health.

The Department of Environment, Food and Agriculture makes the following Declaration under article 18(1) of the Trade in Animals and Related Products Order 2020<sup>1</sup> and declares the following special measures to be necessary in the Isle of Man in order to contain the risk to human or animal health.

#### 1 Title

This Declaration is the Trade in Animals and Related Products Declaration of Special Measures (Chronic Wasting Disease).

#### 2 Commencement

This Declaration comes into operation on the day after it is made.

# 3 Interpretation

In this Declaration —

"cervid" means animals of the family Cervidae;

"RUF" means the 'Model health certificate for fresh meat, excluding offal and minced meat, of farmed non-domestic animals of the order Artiodactyla (excluding bovine animals (including Bison and Bubalus species and their cross-breeds), Ovis aries, Capra hircus, Suidae and Tayassuidae), and of the families Rhinocerotidae and Elephantidea from non-EU





countries' as it is published by the UK Government from time to time; and

"RUW" means the 'Model health certificate for fresh meat, excluding offal and minced meat, of wild non-domestic animals of the order Artiodactyla (excluding bovine animals (including Bison and Bubalus species and their cross-breeds), Ovis aries, Capra hircus, Suidae and Tayassuidae), and of the families Rhinocerotidae and Elephantidea from non-EU countries' as it is published by the UK Government from time to time.

## 4 Suspension of entry of certain products into the Isle of Man

- (1) Entry into the Isle of Man is suspended for urine hunting lures derived from cervids originating in or dispatched from the United States of America, Canada, Republic of Korea, Norway, Sweden or Finland.
- (2) Entry into the Isle of Man is suspended for live cervids originating in or dispatched from Norway, Sweden or Finland.
- (3) Entry into the Isle of Man is suspended in respect of fresh cervid meat originating in or dispatched from Norway, Sweden or Finland, except such meat that complies with the supplementary guarantee for chronic wasting disease
  - (a) at point II.1.7 of the veterinary certificate RUF; or
  - (b) at point II.1.8 of the veterinary certificate RUW.

### **EXPLANATORY NOTE**

## (This note is not part of the Declaration)

This Declaration introduces importation controls on urine hunting lures (cervid products) from the United States of America, Canada and Republic of Korea, and cervids and fresh cervid meat originating from Norway, Sweden and Finland, except where such meat complies with the supplementary guarantee in a veterinary certificate RUF or RUW confirming the absence of chronic wasting disease. These measures are as a result of an outbreak of chronic wasting disease.
