## REGISTRATION OF BIRTHS AND DEATHS (FEES) REGULATIONS 2023

*Approved by Tynwald: 22nd November 2023*

*Coming into operation in accordance with regulation 2*

The Treasury makes the following Regulations under section 43(2) of the Civil Registration Act 1984.

### **1 Title**

These Regulations are the Registration of Births and Deaths (Fees) Regulations 2023.

### **2 Commencement**

If approved by Tynwald, these Regulations come into operation on 1 April 2024<sup>1</sup>.

### **3 Fees**

The fees payable under the Civil Registration Act 1984 are prescribed in the table in the Schedule as follows —

- (a) column 1 specifies the provisions of the relevant legislation under which a matter arises for which a fee is payable;
- (b) column 2 specifies the matter in respect of which a fee is payable; and
- (c) column 3 prescribes the relevant fee in respect of the matter described in the corresponding row in column 2.

### **4 Revocation**

The Registration of Births and Deaths (Fees) Regulations 2016<sup>2</sup> are revoked.
