MARRIAGE AND CIVIL PARTNERSHIP (VENUES, ETC.) (FEES) ORDER 2023

Laid before Tynwald: 21st November 2023 Coming into operation in accordance with article 2

The Treasury makes the following Order under section 81 of the Interpretation Act 2015.

1 Title

This Order is the Marriage and Civil Partnership (Venues, etc.) (Fees) Order 2023.

2 Commencement

This Order comes into operation on 1 April 2024¹.

3 Fees

Fees are prescribed in the table in the Schedule as follows —

- (a) column 1 specifies the provision under which a matter arises for which a fee is payable;
- (b) column 2 specifies the matter in respect of which a fee is payable; and
- (c) column 3 prescribes the relevant fee in respect of the matter described in the corresponding row in column 2.

4 Revocation

The Marriage and Civil Partnership (Venues, etc.) (Fees) Order 2016² is revoked.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order prescribes the fees payable in respect of services and functions in connection with civil marriage and civil partnership ceremonies.

The fees payable relate to:

- the approval of the Registrar General of venues for the purposes of the solemnization of civil marriages under section 19 of the Marriage Act 1984 and the formation of civil partnerships under section 7 of the Civil Partnership Act 2011;
- the consent of the Registrar General to the holding of a civil marriage ceremony or registration of a civil partnership at a venue other than a registrar's office or approved venue;
- additional site visits to a place prior to approval;
- administration in respect of changes in relation to an approved place;
- the use of the registrar's office for a ceremony;
- a rehearsal at the approved place for a rehearsal in relation to the booked ceremony;
 and
- changing the date or time of the ceremony.

This Order revokes the Marriage and Civil Partnership (Venues, etc.) (Fees) Order 2016 [SD 2016/0206].
