#### History

The site is known to have been used for Christian worship since approximately 500AD. The present building was erected in 1774, being a rebuild of a building constructed between 1720 and 1730.

The church is dedicated to Saint Sanctain, an Irish Saint and Bishop. During the 17<sup>th</sup> century, St Sanctain's connection with the church was forgotten, with the church mistakenly dedicated to St Ann. This mistake was perpetuated in Blundell's account of the island in 1648. The last reference to St Ann in the church registers was in 1822, when further uncertainty occurred with the church dedication attributed to St Anne. This spelling lasted until 1891, when the restoration of the dedication to Saint Sanctain appears to have occurred.

A new pitched roof was constructed in 1932, and at this time a number of pews were removed to make room for the existing chancel. The vestry was formed in 1951, and in 1952 the east wall's stained glass window was installed.

#### **Form and Materials**

The church is constructed of local stone, rendered externally and painted white. The roof is supported by timber A-frame trusses, with purlins, rafters and close boarded timber panels all visible from the interior. The roof is finished in natural slate (Welsh). The internal walls are timber panelled to dado height.

The church has a simple rectangular form, with a bell tower on the western gable. A gallery is present at the western end, accommodating the organ and additional seating at gallery level and under which the vestry and baptistry have been constructed.

Against the western internal wall, adjacent to the baptistry, are three stone crosses. Two depict forms of the cross. The third is believed to be the only engraved stone of its type on the island. The stone's Latin inscription reads 'A VITI MONOMENTI' — meaning the tomb of Avitus. No facts are known about the identity of the Manx Avitus. The style is similar to monuments found in Cornwall, south west Wales and southern Scotland. The name Avitus may indicate contact between the island and continental Europe, as the name was popular in northern France.

#### **Reasons for Registration**

Santon Parish Church (St Sanctain's), is included in the Protected Buildings Register for the following reasons:

• Parish church dating from 1774 with many surviving elements of historic fabric and examples of architectural detailing.

#### **HISTORIC INTEREST:**

• Parish church illustrating important aspects of the nation's religious history and the social and cultural history of Santon Parish.
