



Reasons for Registration

Derby House (The Old Post Office), Castletown, is included in the Protected Buildings Register for the following reasons:

ARCHITECTURAL INTEREST:

- The building is a surviving example of a mid-19th century property with commercial and residential uses that retains much of its historic form, together with elements of its historic fabric and detailing.

HISTORIC INTEREST:

- Dating from the mid-19th century, the building is known to have been used as a Draper's from at least the 1880s, and subsequently as a restaurant and a Post Office. The property's mixed commercial uses since the mid-19th century help illustrate elements of the nation's economic and social history.
