To remove an ex-spouse or civil partner, please complete Part B (page 3 if you are the applicant, page 4 for an Advocate signing on behalf of a client).

Supporting evidence to be submitted

To add a spouse or civil partner - Please note that a certified copy of the relevant marriage/civil partnership document must be submitted in support of a declaration made under Part A.

To remove a spouse or civil partner - when completing part B in circumstances where a divorce/dissolution has been ordered by a Court, please provide a certified copy of the Court Order with the declaration.
