POSTAL VOTERS

The Elections (Keys and Local Authorities) Act 2020 provides that a person who is or will be entitled to vote at an election may apply to the Deputy

Returning Officer of their constituency to vote by post. Applications to be treated as a postal voter must be made on an Application

for a Postal Vote form, which must be submitted to the relevant Deputy Returning Officer:

- If the postal ballot paper is to be marked within the Isle of Man not later than 10 April 2024;
- If the postal ballot paper is to be marked within the British Isles, but outside the Isle of Man not later than 04 April 2024;
- If the postal ballot paper is to be marked overseas (outside the Isle of Man and the British Isles) - not later than 26 March 2024.
