Who should apply using this form?

1 This application form should only be completed by individuals who are already in the Isle of Man.

You should use the application form if you are:

- Currently in the Isle of Man as a main applicant under the Tier 1 (Investor) and seeking to extend their leave for a further period within their existing category;
- Currently in the Isle of Man under the Investor category in place before we introduced the Tier 1 (Investor) category and seeking an extension under Tier 1 (Investor).

This application form should not be used by dependents of main applicants. A separate application form titled FLR (DEP) form is available for this purpose and can be found on the website as above.

Submitting a valid application

- **2** You will only be considered to have submitted a 'valid' application if the following has been complied with:
 - the correct application form must be completed and submitted
 - the correct application fee must be paid
 - your current passport, Biometric Residence Permit (BRP) if applicable or travel document must be provided, unless it is not available for one of the reasons specified on the application form.
 - the mandatory sections in the application form must be completed.

Supporting Evidence

- (c) the date that you received a notice confirming that an application was not valid, provided that the application was submitted before the time limit attached to your last period of leave expired.

If you wish to remain in the UK after the 28 day period you should leave the UK and reapply for a visa.

You should confirm whether you have ever remained beyond the end of your period of leave in the Isle of Man, UK or Channel Islands. Where your leave has been extended by virtue of Section 3C of the 1971 Immigration Act, you will not be considered to have remained beyond the end of your period of leave and should therefore complete the 'No' box in response to this question.

3.9 We will carry out criminal record checks on all applicants and dependants. You must give details of all unspent and spent criminal convictions. This includes road traffic offences but not fixed penalty notices (such as speeding or parking tickets) unless they were part of a sentence of the court. This includes all drink-driving offences.
