We need to work to keep our village attractive to those wishing to benefit from its facilities, and the Commissioners must play a role in making sure appropriate facilities are available. In particular, the beaches should be properly managed to ensure they remain attractive to children and sportspeople alike.

I feel it cannot be healthy for any Commissioner to be involved in significant financial and legal transactions with the Commissioners, or for the public to be unable to know the details of discussions or decisions made at meetings.
