How to apply

Submit your application in person to the Welcome Centre along with:

- Your completed application form
- The fee of £10 in cash, credit/debit card or cheque (payable to Isle of Man Government).
- Your original (or certified copy) birth/adoption certificate
 or current photo driving licence showing your date of
 birth and a recent passport quality photograph of yourself
 authorised by your Countersignatory (see Notes for the
 Countersignatory below);

Or:

 Your current passport or EU identity card and a recent passport quality photograph of yourself

Change of name

If your current name is not that shown on your proof of identity you must also provide an official document such as a marriage certificate or deed poll to prove your change of name.

Notes for the Countersignatory

To qualify as a Countersignatory you must meet all of the following criteria:-

- Be resident on the Island;
- Have no family connection with the applicant (including that of guardian, foster parent or carer);
- Have known the applicant personally for two years;
- Be over 25 years of age; and
- Be a professionally qualified person, for example, Member of Tynwald, Minister of recognised Religion, Advocate, Bank Officer, Civil Servant, School Teacher, College Lecturer, Police Officer, Local Authority Representative

or Doctor (a full list of the acceptable Countersignatories is available at www.gov.im/proof-of-age or from the Welcome Centre.

The Welcome Centre procedures include a check on the authenticity of Countersignatories. You may under some circumstances be asked to produce further evidence of your identity.

Before completing Section B please read the Terms and Conditions of Issue. You must be certain that the applicant is over 18 and should ask them to provide you with official proof of this.

The applicant will provide you with a recent passport sized photograph which you should sign, date and endorse with the words

"I CERTIFY THAT THIS IS A TRUE LIKENESS OF (APPLICANTS NAME)".

Passport/EU identity card holders

If you provide an EU identity card or a non-EU passport as proof of your date of birth and identity you should be aware that the validity of the documents may be subject to checks with the relevant Isle of Man authorities.

Terms and Conditions of Issue

You must read these before making an application for a card.

The card remains the property of the Isle of Man Government. The card may only be used by the authorised holder, who is the person named on the card whose photo appears on the card.

- 1. If an application is incomplete or inaccurate we will contact you to obtain the necessary information to process the application. The card is issued at the sole discretion of the Welcome Centre, which reserves the right not to issue a card if dissatisfied with the contents of the application.
- 2. The card holder is responsible for ensuring that the card is not misused, lent, transferred or stolen. Misuse of the card may result in it being withdrawn.
- 3. Any applicant who provides false information may be liable to prosecution.
- 4. If you lose your card you should advise the Welcome Centre straight away. The charge for a replacement card is £10. The replacement card will have the same expiry date as your previous card.
- 5. A maximum of 3 cards can be issued to a person in a given 12 month period.

Data Protection

Information provided by applicants will be used only for the purpose of issuing the card and no other purpose.

Information stored by the card applicant will be digitally stored by the Isle of Man Government for the life of the card (5 years)
