IMMIGRATION (DESIGNATION OF TRAVEL BANS) ORDER 2014

Laid before Tynwald:

Coming into Operation: 16 October 2014

The Council of Ministers makes the following Order under section 8B(5) and (6) of the Immigration Act 1971(of Parliament), as that Act has effect in the Island¹.

1 Title

This Order is the Immigration (Designation of Travel Bans) Order 2014.

2 Commencement

This Order comes into operation on 16 October 2014.

3 Interpretation

In this Order, "the Act" means the Immigration Act 1971 (of Parliament) as it has effect in the Island.

4 Designated Instruments

The instruments listed in the Schedule are designated under section 8B(4) and (5) of the Act.

5 Disapplication of section 8B of the Act

Section 8B of the Act does not apply in any case if—

- (a) failure to apply the section would not be contrary to the United Kingdom's obligations under any of the instruments designated by article 4 of this Order,
- (b) to apply these provisions would be contrary to the United Kingdom's obligations under the Convention for the Protection of Human Rights and Fundamental Freedoms, agreed by the Council of Europe at Rome

- on 4 November 1950 as it has effect for the time being in relation to the Isle of Man, or
- (c) to apply the section would be contrary to the United Kingdom's obligations under the Convention relating to the Status of Refugees done at Geneva on 28th July 1951 and the Protocol to that Convention.

6 Revocation

The Immigration (Designation of Travel Bans) (No. 3) Order 2013² is revoked.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order revokes and replaces the Immigration (Designation of Travel Bans) (No. 3) Order 2013. Any person named by or under an instrument listed in the Schedule to this Order or falling within a description in such an instrument will be excluded from the Isle of Man (subject to the exceptions specified in Article 5).

The Order prescribes a revised list of instruments of the United Nations and the European Union which are designated for the purpose of section 8B(4) and (5) of the Immigration Act 1971, as that Act has effect in the Island.
