#### History

The two beach side cottages at Niarbyl do not have a definitive build date. Background information provided by Manx National Heritage in support of a 2003 planning application suggests that the cottages are likely to date from the 18<sup>th</sup> century, although as vernacular building techniques and materials varied little over the course of numerous centuries, it is possible that the cottages date from the 17<sup>th</sup> century or the early 19<sup>th</sup> century. It is not certain whether the cottages are of the same age, or whether one pre-dates the other. The cottages are shown on the first edition ordnance survey map from the 1860s.

Historically the beach at Niarbyl was used as the base for herring boats fishing the waters between Niarbyl and Peel, although the importance of Niarbyl for this purpose is thought to have declined rapidly from the 1850s onwards. The 1851 census listed five families (at Niable), three of which were headed by full time fishermen. By the time of the census in 1881, only one family was recorded as permanently living at Niarbyl.

The Manx museum's archive includes photographs and images from circa 1860s onwards, and these records appear to suggest that the cottages are largely unchanged from this period.

## **Form and Materials**

The two cottages are single storey, with a thatched pitched roof. Both gables and the party wall have chimney stacks. The western cottage is open plan internally, while the eastern cottage has a single dividing wall to the right of the entrance door. Both cottages are three bays. Walls are constructed of Manx stone, with a lime wash finish. Doors and windows are painted timber. There is a single high level window in the north facing wall of the western cottage.

The stone projecting pegs in the walls (bwoid suggane) – used to secure the roof thatching – are still in place, as are the projecting slates within the chimneys that serve to divert water away from the internal walls.

### **Reasons for Registration**

Thatched House (formerly two cottages), Niarbyl, is included in the Protected Buildings Register for the following reasons:


### **ARCHITECTURAL INTEREST:**

## **HISTORIC INTEREST:**

 A unique surviving example on the island of a pair of vernacular thatched cottages in a beachside setting; and specifically illustrating the history of the community at Niarbyl in the 18<sup>th</sup> and 19<sup>th</sup> century that fished the waters between Niarbyl and Bradda.
