**REGISTER OF
ELECTORS:**

NOTICE IS HEREBY GIVEN THAT revised Registers of Electors will be available for public inspection under supervision at the offices of the REGISTRATION OFFICER at the **ELECTORAL REGISTRATION UNIT, 2 CIRCULAR ROAD, DOUGLAS**, AND AT THE PLACES MENTIONED IN THE SCHEDULE HEREUNDER, from 1st October 2008.

An application to be included in the 2008/09 Register, or for the alteration of an entry or a change of address, must be made in writing to the Registration Officer by 17th December 2008. Lists of such applications will be available for public inspection, at the places detailed below and subject to such restrictions as detailed above, from 19th December 2008.

**MARKING OF
JURORS:**

The letter 'J' against a person's name in the Register of Electors means that he/she will be included in the Jurors List as liable for jury service.

ANY PERSON whose name is so marked and who is under the age of 18, over the age of 65 or who is exempt from service as a juror by reason of occupation or mental incapacity should apply in writing to the Registration Officer.

FURTHER, any person whose name is so marked, and to whom jury service would cause exceptional hardship, should apply in writing to the Registration Officer, stating the grounds for the application.

THE CLERK OF THE ROLLS will consider all such applications, and may invite oral representation to be made to a Deemster in Chambers, and if satisfied that attendance as a juror will cause exceptional hardship, may order that an application be exempted from jury service for a period not exceeding three years.

**Revision
of
Register**

ANY PERSON who is so entered, or claims to be entitled to be entered, and objects-

- (a) to the entry of another person in the register; or
- (b) to a claim by another person to be entitled to be entered;

may make an objection in writing to the Registration Officer. An objection under (a) must be made by 24th December 2008. An objection under (b) must be made by 29th December 2008.

ALL SUCH objections will be the basis of additional lists to be prepared and available for public inspection at the places specified below.

CLAIMS OR OBJECTIONS may require to be referred to a revision court, which shall be held when required.
