### Change to Crawfish minimum conservation reference size in ICES area 7

In 10m and Under Schedules:

5.3 In ICES sea area 7 (of English waters), the minimum conservation reference size for crawfish (*Palinurus spp.*) shall be 110mm and shall be measured, as the length of the carapace, parallel to the midline, from the tip of the rostrum to the midpoint of the distal dorsal edge of the carapace.
