The Department gives notice of the effect of this Authorisation.

In this notice, "TT period" means the period from and including 24 May 2024 up to and including 11 June 2024.

## SUPPLEMENTAL PROVISIONS

(2) The Department makes the following consequential, incidental or supplemental arrangements which are necessary and appropriate for the proper conduct of the race -
(a) the parking places on the south-east side of the A2 New Road, Laxey, are suspended and a person must not cause or permit a motor vehicle to wait -
(i) from a point adjacent to property no 45 in a northerly direction to the southern boundary of the bus stop adjacent to Laxey Commissioners Office; and
(ii) from its junction with Church Hill to its junction with the railway crossing at the Mines Tavern, during the TT period;
(b) a person must not cause or permit a motor vehicle to wait on -
(i) TT Access Road, Douglas and Braddan, between its junction with the A5 Douglas to Castletown Road and its junction with River Vale, Braddan Hills, Braddan;
(ii) Creg-ny-Baa Back Road, Onchan, between its junction with the course and a point 500 metres in a north-easterly direction;
(iii) Orrisdale Road, Kirk Michael, between the southern boundary of the old railway bridge and the path to Rhencullen (a distance of 210 metres);
(iv) Vicarage Road, Braddan, between its junction with Saddle Road and its junction with Vicarage Park,
during any closure period;
(c) a person must not cause or permit a motor vehicle to use Claughbane Walk, Ramsey, for access or egress to or from the A18 Mountain Road during the TT period;
(d) Church Road Marina is closed to motor vehicles between Market Street and Harris Promenade at such times as may be necessary to facilitate the passage of traffic during the TT period;
(e) pedestrians are prohibited on the TT Access Road, Douglas and Braddan, from its junction with the A5 Douglas to Castletown Road to its junction with River Vale, Braddan Hills, Braddan during any closure period;
(f) cycling is permitted on the northern footway of Old Castletown Road between Bridge Road/South Quay and PROW 223 (Nunnery to Groves Road); and
(g) cycling is prohibited on the A18 Mountain Road from the Ramsey hairpin to its junction with the Creg-ny-Baa Back Road during the TT period.
