Road Transport Licensing Committee Monthly Newsletter GOODS VEHICLES APPLICATIONS, DECISIONS AND NOTICES

Notice Period

The Road Transport Regulations 2018 require the Road Transport Licensing Committee ("the RTLC" or "the Committee") to publish details of applications, meetings and decisions.

Copies of all applications are available at the RTLC office.

Within a period of 21 days from the date of this publication, any person may write to the Committee making any objections or representations with respect to the application.

Written objections can be received by letter or email. They should include the name and address of the sender and include the reasons why the objection or representation is made. They should be sent to the applicant's registered address as well as to the RTLC office. For the full RTLC Procedure detailing the submission of objections please see the RTLC website; www.gov.im/rtlc.

NOTICES

The RTLC office has received many queries regarding trailers and whether they need to be registered or not. Hopefully the following guidance will help:

Any vehicle constructed or adapted to carry goods that has a maximum gross vehicle weight (i.e. the weight of the vehicle plus the driver and any load) that exceeds 3,500 kg must be operated under an Operator Registration or Operator Licence as per the Road Transport Regulations 2018. All such vehicles will require an operator disc.

Similarly, any trailer constructed or adapted to carry goods that has a maximum gross vehicle weight (i.e. the weight of the trailer plus any goods carried) that exceeds 3,500 kg must also be registered and will require an operator disc.

Any vehicle and trailer combination that has a combined maximum gross weight that exceeds 3,500 kg will also require the operator to have either a Registration or Licence.

For example, a pickup truck with a gross vehicle weight of 3,200 kg may be operated without an Operator's Licence or Registration. However, if that vehicle is towing a trailer and the gross vehicle weight of the combination exceeds 3,500 kg an Operator's Licence or Registration will be required authorising 1 goods vehicle and 1 trailer. While you will need authorisation for both vehicles in this example, you will only require an operator disc for the goods vehicle.

Further guidance documents in the form of a "Guide to Operator Licensing" and a "Goods Vehicles Maintenance Guide" are available on the RTLC website; www.gov.im/rtlc along with the latest versions of the application forms.

APPLICATIONS

1. Colas (IoM) Ltd.

The applicant wishes to apply for an Operator Registration and register 10 goods vehicles under the Road Transport Regulations 2018.

The applicant's registered address is identified in their application as Broom House, Billown Quarry, Ballasalla, IM9 3DW and the four proposed operating centres are listed as;

- Peel Road, Braddan
- Balthane Industrial Estate, Ballasalla
- Billown Quarry, Ballasalla
- Turkeyland Quarry, Ballasalla

The applicant does not need to obtain planning approval for any of the operating centres.

2. Auldyn Construction Ltd.

The applicant wishes to apply for an Operator Registration and register 14 goods vehicles under the Road Transport Regulations 2018.

The applicant's registered address is identified in their application as Broom House, Billown Quarry, Ballasalla, IM9 3DW and the four proposed operating centres are listed as;

- Peel Road, Braddan
- Balthane Industrial Estate, Ballasalla
- Billown Quarry, Ballasalla
- Turkeyland Quarry, Ballasalla

The applicant does not need to obtain planning approval for any of the operating centres.

3. Birchall Plant Hire Ltd.

The applicant wishes to apply for an Operator Registration and register four goods vehicles under the Road Transport Regulations 2018.

The applicant's registered address is identified in their application as 18 Larivane Meadows, Andreas, IM7 4JD and the proposed operating centre is listed as The Technical Site, Andreas Airfield, Andreas.

The applicant does not need to obtain planning approval for the operating centre.

4. Dandara Homes Ltd.

The applicant wishes to apply for an Operator Registration and register four goods vehicles under the Road Transport Regulations 2018.

The applicant's registered address is identified in their application as Dandara Head Office, Isle of Man Business Park, Cooil Road, Braddan, IM2 2SA and the proposed operating centre is listed as Dandara Compound, off Richmond Hill, Braddan.

Planning approval or a certificate of lawfulness may be required for the operating centre.

5. Ace Hire and Sales Ltd.

The applicant wishes to apply for an Operator Registration and register two goods vehicles along under the Road Transport Regulations 2018.

The applicant's registered address and the proposed operating centre is identified in their application as Unit 10, South Quay Industrial Estate, Douglas.

The applicant does not need to obtain planning approval for the operating centre.

6. Edward Bryan Removals Ltd.

The applicant wishes to apply for an Operator Licence to operate four goods vehicles along with under the Road Transport Regulations 2018.

The applicant's registered address is identified in their application as Bryan House, Villa Marina Road, Douglas, IM1 2HR and the proposed operating centre is listed as Unit F6, Balthane Industrial Estate, Ballasalla.

The applicant does not need to obtain planning approval for the operating centre.

7. T. E. Leece & Son Ltd.

The applicant wishes to apply for an Operator Registration and register one goods vehicle under the Road Transport Regulations 2018.

The applicant's registered address and the proposed operating centre is identified in their application as Builders' Yard, Main Road, Colby, IM9 4LR.

Planning approval or a certificate of lawfulness may be required for the operating centre.

8. Macs Builders Merchants Ltd.

The applicant wishes to apply for an Operator Registration and register three goods vehicles under the Road Transport Regulations 2018.

The applicant's registered address and the proposed operating centre is identified in their application as Main Road, St. John's, IM4 3LU.

The applicant does not need to obtain planning approval for the operating centre.

9. A V Craine & Sons Ltd.

The applicant wishes to apply for an Operator Registration and register five goods vehicles under the Road Transport Regulations 2018.

The applicant's registered address is identified in their application as 1 Garey Close, Mines Road Foxdale, IM4 3EU and the proposed operating centre is listed as Cringle Quarry, Ronague, Arbory.

The applicant does not need to obtain planning approval for the operating centre.

10. Manx Independent Carriers Ltd.

The applicant wishes to apply for an Operator Registration and register 20 goods vehicles along with 100 trailers, each with a maximum gross vehicle weight over 3,500 kg, under the Road Transport Regulations 2018.

The applicant's registered address and the proposed operating centre is identified in their application as Distribution Centre, Snugborough Trading Estate, Union Mills, IM4 4LG.

The applicant does not need to obtain planning approval for the operating centre.

11. JCK Ltd.

The applicant wishes to apply for an Operator Registration and register 25 goods vehicles along with 10 trailers, each with a maximum gross vehicle weight over 3,500 kg, under the Road Transport Regulations 2018.

The applicant's registered address is identified in their application as Portview, Balthane Industrial Estate, Ballasalla, IM9 2AJ and the two proposed operating centres are listed as;

- Portview, Balthane Industrial Estate, Ballasalla
- Recycle Yard, Balthane Road, Ballasalla

The applicant does not need to obtain planning approval for either operating centre.

12. GF Fork Trucks Ltd.

The applicant wishes to apply for an Operator Registration and register two goods vehicles under the Road Transport Regulations 2018.

The applicant's registered address and the proposed operating centre is identified in their application as Unit 1, Close Chiarn, Mill Road, Peel, IM5 1TB.

The applicant does not need to obtain planning approval for the operating centre.

13. Paul Carey & Sons Ltd.

The applicant wishes to apply for an Operator Registration and register five goods vehicles along with two trailers, each with a maximum gross vehicle weight over 3,500 kg, under the Road Transport Regulations 2018.

The applicant's registered address is identified in their application as R. H. Corkill & Co. Ltd., 10 Auckland Terrace, Ramsey, IM8 1AF and the two proposed operating centres are listed as;

- Andreas Recycling Yard, Technical Site, Andreas Airfield, Andreas
- Ballasalla Farm Workshop, Jurby West

Planning approval or a certificate of lawfulness may be required for the Ballasalla Farm Workshop operating centre. The applicant does not need to obtain planning approval for the other operating centre.

14. Isle of Man Seafood Products Ltd.

The applicant wishes to apply for an Operator Registration and register 20 goods vehicles under the Road Transport Regulations 2018.

The applicant's registered address and the proposed operating centre is identified in their application as Manx Cold Storage Building, Mill Road, Peel, IM5 1TA.

The applicant does not need to obtain planning approval for the operating centre.

15. Mr S Morrey

The applicant wishes to apply for an Operator Registration and register three goods vehicles along with five trailers, three of which have a maximum gross vehicle weight over 3,500 kg, under the Road Transport Regulations 2018.

The applicant's registered home address is identified in their application as Ballacorey Farm, Ballacorey Road, Andreas, IM7 4EL and the and the two proposed operating centres are listed as;

- Braust Farm, Andreas Airfield, Andreas
- Ballacorey Farm, Ballacorey Road, Andreas

Planning approval or a certificate of lawfulness may be required for both operating centres.

DECISIONS

1. Chris Kissack Ltd.

To register fifteen goods vehicles along with one trailer, which has a maximum gross vehicle weight over 3,500 kg, under the Road Transport Regulations 2018.

The applicant's registered address was identified as Flat 2, Crosby House, Main Road, Crosby, IM4 4BP and the proposed operating centre was identified as Rose Villa, Kissacks Lane, Crosby.

An assurance regarding the suitability of the proposed centre was not required from the Planning Section at DEFA.

The application was approved.

2. Ramsey Town Commissioners

To register four goods vehicles under the Road Transport Regulations 2018.

The applicant's registered address was identified as Town Hall, Parliament Square, Ramsey, IM8 1RT and the proposed operating centre was identified as Riverside Workshops, Poylldooey Road, Ramsey.

An assurance regarding the suitability of the proposed centre was not required from the Planning Section at DEFA.

The application was approved.

3. Transmann Ltd.

To register five goods vehicles and two trailers under the Road Transport Regulations 2018.

The applicant's registered address and the proposed operating centre was identified in the application as The Second Milestone, Peel Road, Braddan, IM4 4LE.

An assurance regarding the suitability of the proposed centre was not required from the Planning Section at DEFA.

The application was approved.

4. J. Qualtrough & Co. Ltd.

To register five goods vehicles under the Road Transport Regulations 2018.

The applicant's registered address was identified in their application as Hope Street, Castletown, IM9 1AN and the two proposed operating centres were listed as;

- Hope Street, Castletown
- Hills Meadow, Douglas

An assurance regarding the suitability of either proposed centre was not required from the Planning Section at DEFA.

The application was approved.

COMMITTEE MEETINGS

The next scheduled RTLC meetings for goods vehicles which will be held in public are currently scheduled to take place on 27th March, 11th April, and 24th April at Thie Slieau Whallian, Foxdale Road, St John's. It is anticipated that the Committee will consider the applications announced in this Circular at one of the April meetings.

All applicants and objectors that are required to attend a meeting will receive a formal invitation letter prior to the meeting.

Should you require information on the timetables for any upcoming meetings, please contact the RTLC office. If you intend to observe any meeting in public that you are not specifically invited to, it would be appreciated if you could inform RTLC staff of your intentions prior to the meeting. This information is required to ensure that there is sufficient space at the meeting to accommodate any observers. Should there not be sufficient space at Thie Slieau Whallian, a different venue for the meeting would have to be found and this could delay proceedings.
