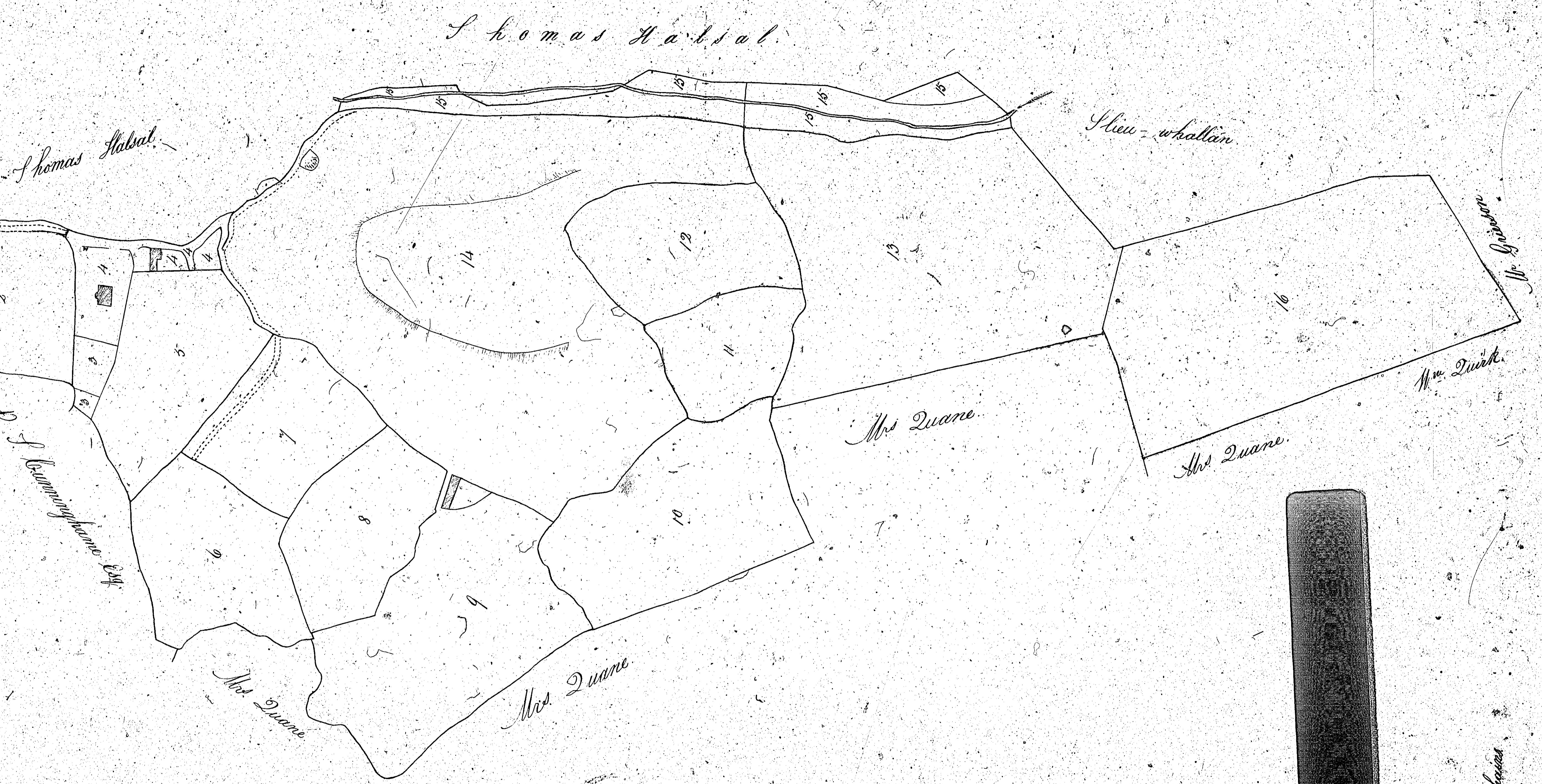

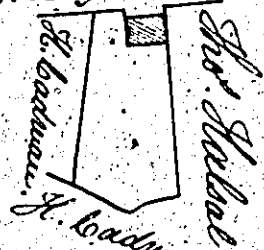

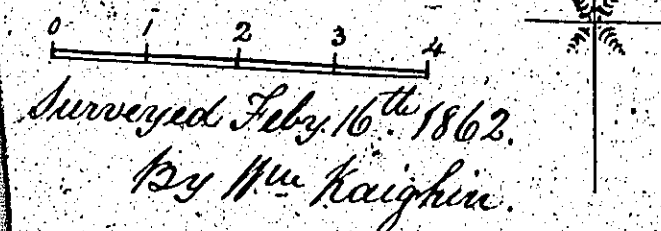
A Plan of part of the

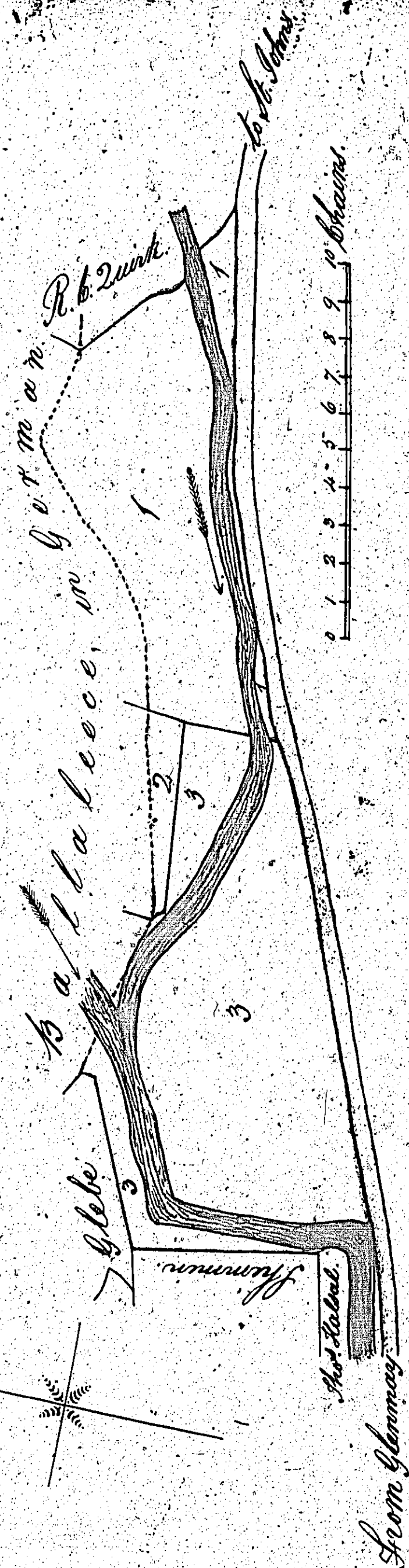
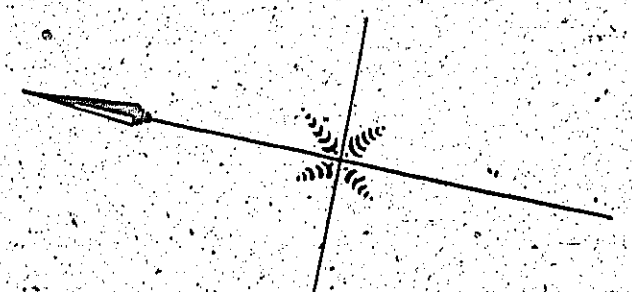

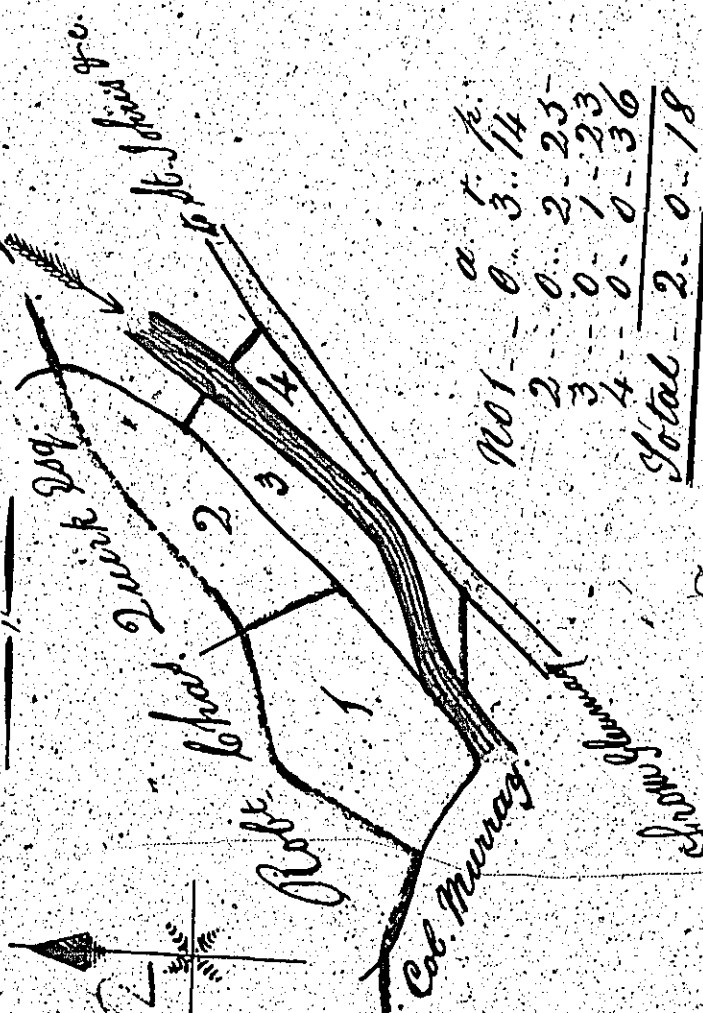

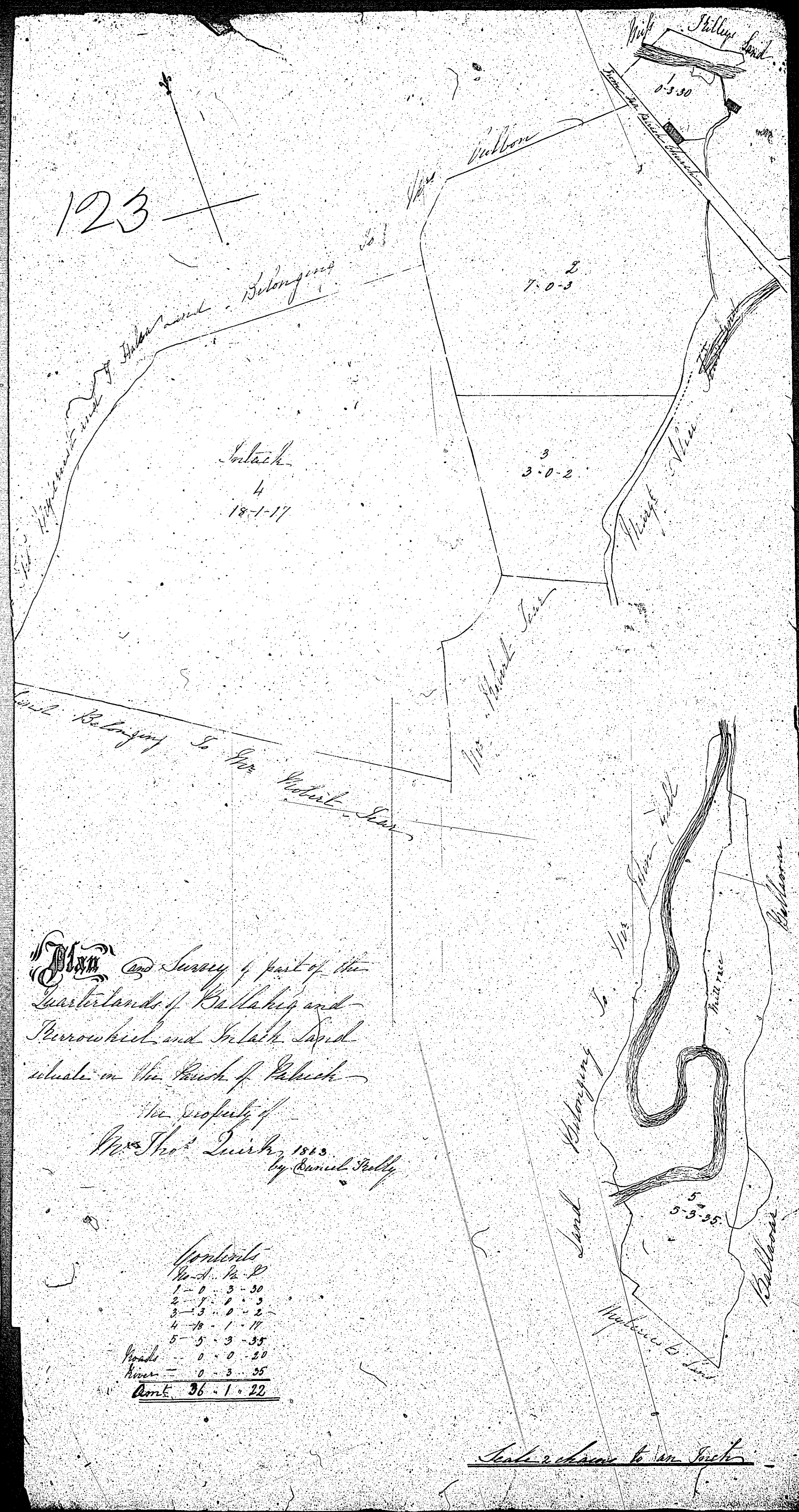
