Many of the larger plans are damaged

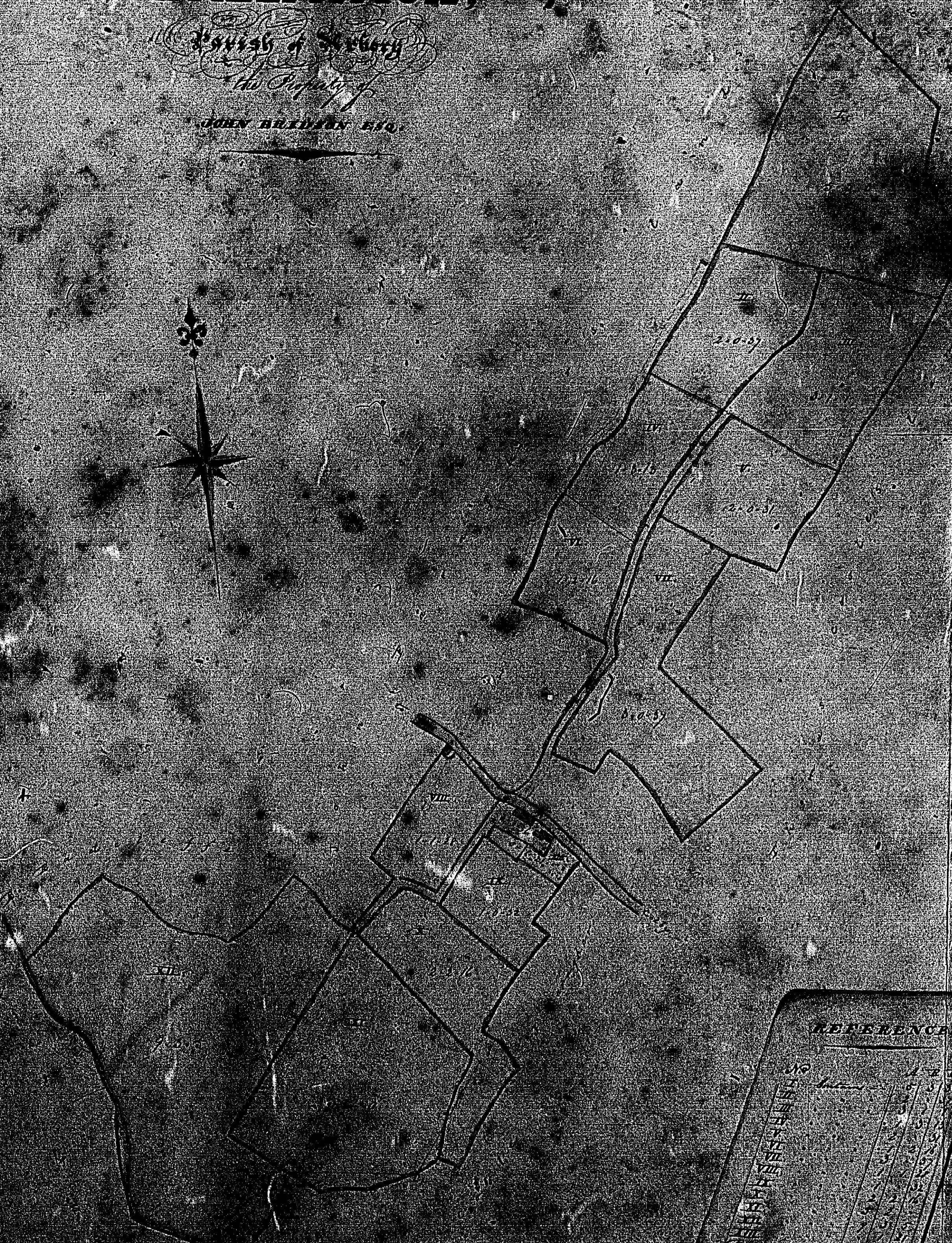
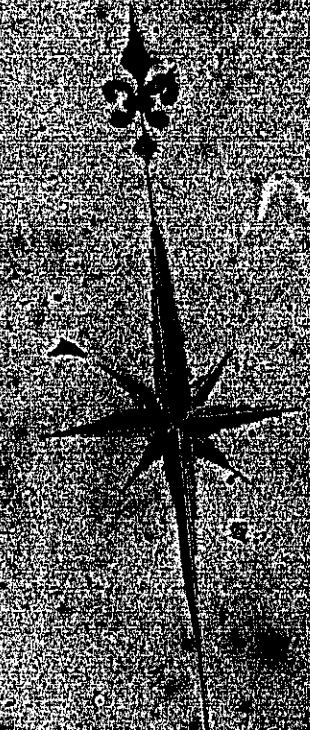

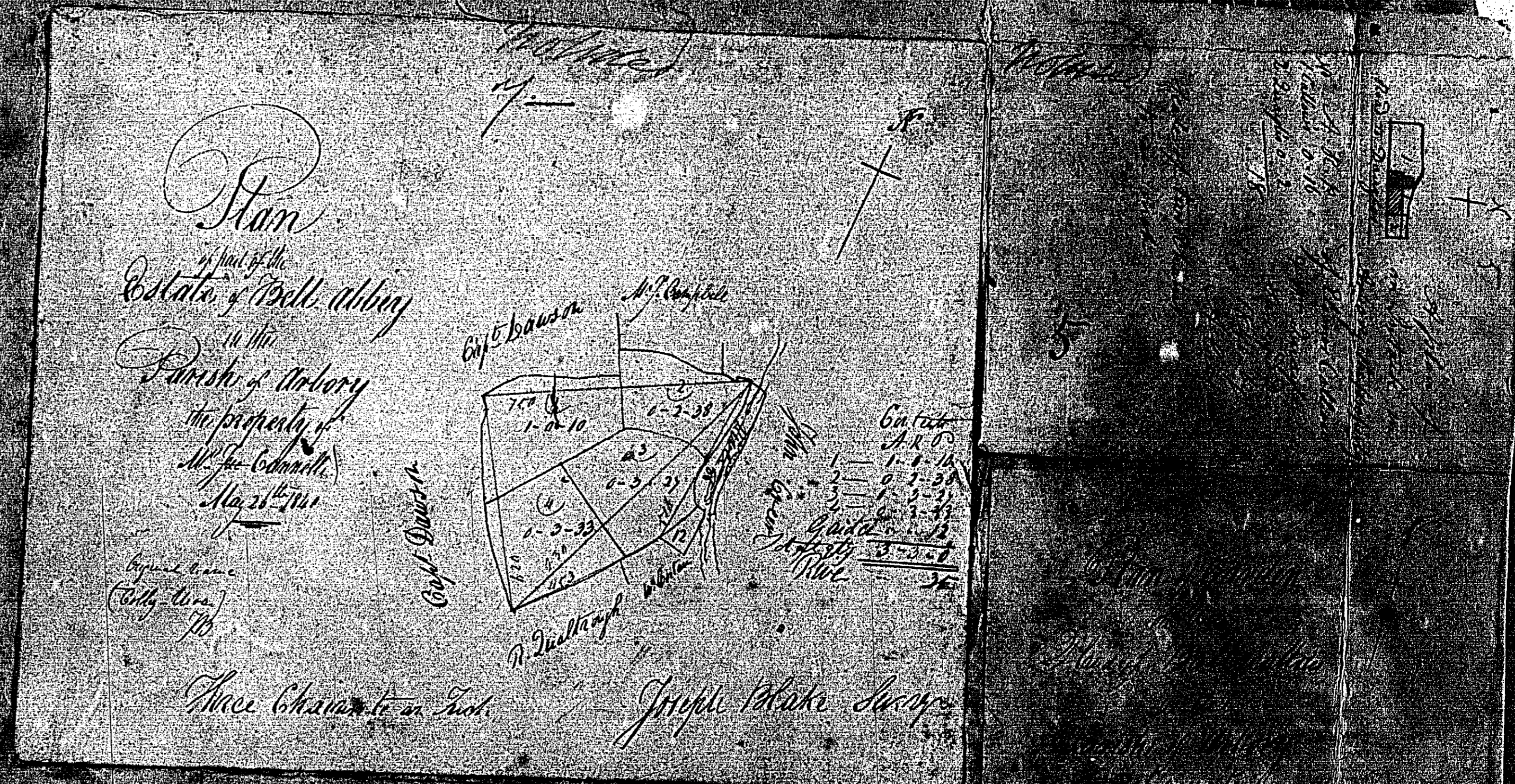
