GOODS VEHICLES APPLICATIONS, DECISIONS AND NOTICES

Notice Period

The Road Transport Regulations 2018 require the Road Transport Licensing Committee (“the RTLC” or “the Committee”) to publish details of applications, meetings and decisions.

Copies of all applications are available at the RTLC office.

Within a period of twenty one days from the date of this publication, any person may write to the Committee making any objections or representations with respect to the application.

Written objections can be received by letter or email. They should include the name and address of the sender and include the reasons why the objection or representation is made. For the full RTLC Procedure detailing the submission of objections please see the RTLC website; www.gov.im/rtlc.

APPLICATIONS

1. Gavin Batty

The applicant wishes to apply for an Operator Registration to operate one goods vehicle and one trailer.

The applicant’s registered address is identified in the application as 1 Convery Close, Onchan and the two proposed operating centres are identified as:

- Ballakelly, Glen Vine Road, Marown
- St Anthony’s, Ridgeway Road, Onchan

The applicant will need to obtain evidence that the operating centres are compliant with the Town and Country Planning Act 1999.
