GOODS VEHICLES APPLICATIONS, DECISIONS AND NOTICES

Notice Period

The Road Transport Act 2001 and the Road Transport Regulations 2018 require the Road Transport Licensing Committee (“the RTLC” or “Committee”) to publish details of applications, meetings and decisions.

Copies of all applications are available on the RTLC website: www.gov.im/rtlc.

Within a period of twenty one days from the date of this publication, any person may write to the Committee making any objections or representations with respect to the application.

Written objections can be received by letter or email. They should include the name and address of the sender and include the reasons why the objection or representation is made. For the full procedure detailing the submission of objections please see the RTLC website.

APPLICATIONS

1. The Village Workshop Ltd

The applicant wishes to apply for an Operator Registration and operate one goods vehicle.

The applicant’s registered address is identified in the application as The Village Workshop Ltd, Glen Road, Laxey and the proposed operating centre is identified as Crossag Farm, Crossag Lane, Ramsey.

The applicant will need to obtain evidence that the operating centre is compliant with the Town and Country Planning Act 1999.
