The Road Transport Act 2001 and the Road Transport Regulations 2018 require the Road Transport Licensing Committee (“the RTLC”) to publish details of applications, meetings and decisions.

## NOTICES

### Trailer testing

This is a reminder that any semi-trailer used under an Operator Registration or Operator Licence must be inspected and licensed annually. Failure to do so is an offence under Section 8 of the Road Transport Act 2001.

## APPLICATIONS

1. Manx Telecom Trading Ltd

To vary the Operator Registration through a change in director/responsible officer.

The applicant currently has approval to operate five goods vehicles.

2. T. C. Q. Limited

To vary the Operator Registration through the addition of one goods vehicle.

There are no new operating centres identified in this application but evidence is still required that the applicant’s existing operating centre is compliant with the Town and Country Planning Act 1999.

The applicant currently has approval to operate four goods vehicles.

3. Island Express Ltd

To vary the Operator Licence through the addition of three goods vehicles.

There are no new operating centres identified in this application.

The applicant currently has approval to operate six goods vehicles and six trailers.

4. Manx Logistics

The applicant wishes to apply for an Operator Registration and operate two goods vehicles.

The applicant's registered address is identified in the application as Upper Billown Farm, Grenaby Road, Ballasalla and the proposed operating centre is identified in the application as Units 24 and 26, Colas Drive, Balthane Industrial Estate, Ballasalla.

The applicant will need to obtain evidence that the operating centres are compliant with the Town and Country Planning Act 1999.

5. Dandara Homes Ltd

To vary the Operator Registration through the addition of one goods vehicle.

There are no new operating centres identified in this application.

The applicant currently has approval to operate four goods vehicles.

6. R Cain Plant Hire Ltd

To vary the Operator Registration through the addition of two goods vehicles.

There are no new operating centres identified in this application but evidence is still required that the applicant's existing operating centre is compliant with the Town and Country Planning Act 1999.

The applicant currently has approval to operate four goods vehicles.

7. Island Landscape Ltd

The applicant wishes to apply for an Operator Registration and operate three goods vehicles.

The applicant's registered address and the proposed operating centre is identified in the application as Unit 229B, Jurby Industrial Estate, Jurby.

The applicant has obtained evidence that the operating centre is compliant with the Town and Country Planning Act 1999.

8. MSN Roofing and Scaffolding Limited

The applicant wishes to apply for an Operator Registration and operate two goods vehicles.

The applicant's registered address is identified in the application as 1 Campion Way, Abbeyfields, Douglas and the proposed operating centre is identified in the application as Barroose Garage, Barroose Road, Baldrine.

The applicant will need to obtain evidence that the operating centre is compliant with the Town and Country Planning Act 1999.

9. Mann Recovery Services

The applicant wishes to apply for an Operator Registration and operate one goods vehicle.

The applicant's registered address is identified in the application as Dreemskerry, Strang and the proposed operating centre is identified in the application as Lower Ballachrink Farm, St. Marks.

The applicant will need to obtain evidence that the operating centre is compliant with the Town and Country Planning Act 1999.

## **DECISIONS**

1. Manx Utilities Authority

To vary the Operator Registration through the addition of 15 goods vehicles.

There were no new operating centres identified in this application.

The applicant currently has approval to operate 45 goods vehicles and two trailers.

**The application was approved.**

2. Manx Utilities Authority

To vary the Operator Registration through the addition of seven operating centres.

The proposed operating centres were identified as:

- MUA Laxey Primary Substation, Minorca Hill, Laxey (maximum of one goods vehicle)
- MUA Castletown Primary Substation, Main Road, Castletown (maximum of one goods vehicle)
- Ballakissack Beg, School Lane, Santon (maximum of one goods vehicle)
- Ballalough Farm, Poortown Road, Peel (maximum of one goods vehicle)
- Trollaby Farm, Trollaby Lane, Union Mills (maximum of one goods vehicle)
- Cronk Chronnee, Braaid Road, St. Marks (maximum of one goods vehicle)
- Ballachrink Lodge, East Baldwin (maximum of one goods vehicle)

The applicant currently has approval to operate 45 goods vehicles and 2 trailers.

**The application was approved.**

3. Manx Utilities Authority

To vary the Operator Licence through a change in the maximum number of vehicles to be kept at their Meary Veg operating centre from 11 goods vehicles and one trailer to 19 goods vehicles and one trailer.

There were no new operating centres identified in this application.

**The application was approved.**

4. CCJ Group Ltd

To vary the Operator Registration through the addition of two goods vehicles.

There were no new operating centres identified in this application.

The applicant currently has approval to operate two goods vehicles.

**The application was approved.**

5. Manx Agri Plant Services Ltd

To vary the Operator Registration through the addition of one goods vehicle.

There were no new operating centres identified in this application.

The applicant currently has approval to operate one goods vehicle.

6. Chris Clarke Ltd (t/a Garden World)

To vary the Operator Registration through the addition of one goods vehicle.

8. Island Tree and Landscaping Services Ltd

To vary the Operator Registration through the addition of one goods vehicle.

The applicant currently has approval to operate three goods vehicles.

All applicants and objectors that are required to attend a meeting will receive a formal invitation letter prior to the meeting.

If you intend to observe any meeting in public that you are not specifically invited to, it would be appreciated if you could inform RTLC staff of your intentions prior to the meeting. This information is required to ensure that there is sufficient space at the meeting to

accommodate any observers. Should there not be sufficient space at Thie Slieau Whallian, a different venue for the meeting would have to be found and this could delay proceedings.
