## Schedule 2 The Protected Buildings Register

Notifications of entries on register etc.

- 2 (1) As soon as may be (practical) after a building has been entered in the register, or the register has been amended by removal of a building from it, the Department shall serve a notice on the owner and the occupier of the building stating that it has been entered in or removed from the register.
  - (2) The owner or the occupier of, and any other person having an interest in, a building which has been entered in the register may apply to the Department to remove the building from the register-
    - (a) within the prescribed period after service on him of a notice under sub-paragraph (1);
    - (b) after the expiration of the prescribed period after the decision of the Department on a previous request under subsection in relation to the building.

#### Under the Town and Country Planning (Registered Buildings) Regulations 2013

#### 5. Periods for purpose of Schedule 2 paragraph 2(2)

- (1) The period specified for the purposes of paragraph 2(2)(a) of Schedule 2 to the Act (period after notice of registration, within which owner or occupier may request de-registration) is 21 days.
- (2) The period specified for the purposes of paragraph 2(2)(b) of Schedule 2 to the Act (period after initial period, during which owner or occupier may not request a de-registration) is 5 years.

#### **Register entry description**

#### **History**

The K8 was introduced in 1968 designed by Bruce Martin. It was used primarily for new sites; around 11000 were installed across Britain, replacing earlier models only when they needed relocating or had been damaged beyond repair.

The K8 retained a red colour scheme, but it was a different shade of red: a slightly brighter "Poppy Red", which went on to be the standard colour across all kiosks. The K8 featured a single large glass panel on two sides and the door.

#### **Details**

FORM and MATERIALS: Mark II model, post 1976. Four-sided rectangular box with a flat roof. Painted cast iron sections bolted together, standing on a concrete base. Single pane windows in door and sides.

#### **Reason for Registration Decision**

Memorial Gardens K8 Telephone Kiosk is recommended for entry into the Protected Buildings Register for the following reasons:

#### •ARCHITECTURAL INTEREST:

• The K8 kiosks were designed by Bruce Martin in a contemporary style, and represent important examples of their building type.

#### •HISTORIC INTEREST:

• The kiosk illustrates important aspects of the island's social history, being important symbols of communication and connectivity in both urban and rural communities on the island.
