Notice Period

The Road Transport Act 2001 and the Road Transport Regulations 2018 require the Road Transport Licensing Committee ("the RTLC") to publish details of applications, meetings and decisions.

Within a period of twenty one days from the date of this publication, any person may write to the RTLC making any objections or representations with respect to an application.

Written objections can be received by letter or email. They should include the name and address of the sender and include the reasons why the objection or representation is made. For the full procedure detailing the submission of objections please see the RTLC website.

CORRECTIONS

The following applications from AD&N Circulars 533 and 535 omitted certain details. The complete, amended, applications are listed below.

From AD&N Circular No. 533

10. Mr M Evans – New Operator Registration

To register as a new operator under Part "A" of the Register of Public Passenger Vehicles through the addition of one Section 29 Ply for Hire vehicle of up to eight passenger seats in the East District, following the transfer of business under the provisions of the Road Transport Regulations 2018, from the previous operator Mr RB Evans.

The application also proposes that Mr JC Staines be appointed as his designated Transport Manager.

The registered address is identified in the application as 18 McLeods Field, Peel. The proposed operating centre is listed as Rose Cottage, Main Road, Santon. This is already an authorised operating centre.

8. Mr BS Hesketh – New Operator Registration

To apply as a new operator under Part "A" of the Register of Public Passenger Vehicles through the addition of one Section 29 Ply for Hire vehicle of up to eight passenger seats in the East District (wheelchair accessible), following the transfer of business under the provisions of the Road Transport Regulations 2018, from the previous operator Mr JC Stevens.

The application also proposes that Mr S Hesketh be appointed as his designated Transport Manager.

The registered address and operating centre is identified in the application as 1 Thirlmere Avenue, Onchan. This is already an authorised operating centre.

This information is required to ensure that there is sufficient space at the meeting to accommodate any observers. Should there not be sufficient space at Thie Slieau Whallian, a different venue for the meeting would have to be found and this could delay proceedings.
