## APPLICATIONS

### 1. Gavin Batty

The applicant wishes to vary an Operator Registration through a change in registered address from 1 Convery Close, Onchan to Narradale, Ballamenagh Road, Baldrine.

There are no new operating centres identified in this application.

The applicant currently has approval to operate one goods vehicle and one trailer.

### 2. JRC Groundworks Ltd

The applicant wishes to apply for an Operator Registration and operate two goods vehicles.

The registered address is identified in the application as 14 Reayrt ny Cashtal, Castletown and the proposed operating centre are identified in the application as Unit 14, Port Way, Balthane Industrial Estate, Ballasalla.

The applicant will need to obtain confirmation that the operating centre is compliant with the Town and Country Planning Act 1999 before the application can be approved.

### 3. Cooley Industries Ltd

- Nobles Hospital, Strang (1 vehicle)

As an existing operator, the applicant will need to obtain confirmation that the operating centres are compliant with the Town and Country Planning Act 1999 before 1<sup>st</sup> January 2024.

The applicant currently has approval to operate 100 goods vehicles and three trailers.

6. Island Civils and Plant Limited

The applicant wishes to apply for an Operator Registration and operate one goods vehicle.

The registered address is identified in the application as 1 Close Corlett, Peel and the proposed operating centre are identified in the application as Oatlands Estate, Oatlands Road, Santon.

The applicant will need to obtain confirmation that the operating centre is compliant with the Town and Country Planning Act 1999 before the application can be approved.

This information is required to ensure that there is sufficient space at the meeting to accommodate any observers. Should there not be sufficient space at Thie Slieau Whallian, a different venue for the meeting would have to be found and this could delay proceedings.
