*Interpretation Act 2015***ROAD TRANSPORT (FEES) ORDER 2023¹***Laid before Tynwald: 18 July 2023**Coming into Operation: 1 August 2023*

The Department of Environment, Food and Agriculture, with the concurrence of the Treasury,¹ makes the following Order under section 81 of the Interpretation Act 2015.²

1 Title

This Order is the Road Transport (Fees) Order 2023.

2 Commencement

This Order comes into operation on 1 August 2023.

3 Interpretation

(1) In this Order —

“**the Act**” means the Road Transport Act 2001;

“**bus**” means a motor vehicle which is constructed or adapted to carry more than 16 seated passengers in addition to the driver;

“**Committee**” means the Road Transport Licensing Committee, as constituted under section 1 of the Act;

“**cortège limousine**” means a large, luxurious passenger car, especially one driven by a chauffeur separated from the passengers by a partition, being a vehicle which is used only in connection with special occasions such as weddings, funerals, banquets or processions;

“**Department**” means the Department of Infrastructure;

“**district**” means any district specified in column 1 of the table in paragraph 3(5) of Schedule 2 to the Act;

- “**minibus**” has the same meaning as in the Road Vehicles (Maintenance and Use) Regulations 2012³;
- “**operator’s disc**” means a disc supplied by the Committee in accordance with section 23(2) of the Act;
- “**Part A**”, in relation to the register, is to be construed in accordance with regulation 24 of the Road Transport Regulations 2018⁴;
- “**Part B**”, in relation to the register, is to be construed in accordance with regulation 24 of the Road Transport Regulations 2018;
- “**passenger car**” has the same meaning as in the Road Vehicles (Maintenance and Use) Regulations 2012;
- “**plying for hire plate**” means the plate, that must be displayed by virtue of regulation 55 of the Road Transport Regulations 2018, on a vehicle in respect of which a service licence granted by the Committee under section 29(1) is in force;
- “**register**” means the register of vehicle operators required to be maintained by the Committee under section 3(1).

4 Fees

- (1) Table 1 of the Schedule sets out the fee to be paid to the Committee by a person making an application to it under section 9, 17, 26, 28, or 30.
- (2) Table 2 of the Schedule sets out the fee to be paid to the Committee by an operator supplied by it with an operator’s disc.
- (3) Table 3 of the Schedule sets out the fee to be paid to the Committee by an operator for plying for hire plates issued by it.
- (4) Table 4 of the Schedule sets out the fee to be paid to the Committee by an applicant for any of the licences to drive a public passenger vehicle to which section 40 refers.
- (5) Table 5 of the Schedule sets out the fee to be paid to the Department by a person applying to it for a review of the carrying capacity of a public passenger vehicles (of a type specified in the Table) pursuant to regulations made under section 46.
- (6) Table 6 of the Schedule sets out the fee to be paid to the Department for the examination or re-examination of public passenger vehicle (of a type specified in the Table) pursuant to regulations made under section 38(1)(b) or (3)(a).
