**Payment system**

Once sold, payment will be made to members based on the price achieved at auction. Payments are made by BACS directly into the member's bank account once the Isle of Man wool has been sold

**Self Billing Agreement**

British Wool pays members under a self-billing process whereby British Wool generates the Payment Advice (rather than the member invoicing British Wool). As such all VAT registered members are required to agree to Self-Billing.

**Trading name**

Given that British Wool generates the Payment Advices for members (rather than invoicing British Wool) we are under an obligation to verify the VAT details that a member provides when they register with British Wool. The trading name for each VAT registered member must be the same as the name on their VAT registration .

**Signatories**

Registration forms should be signed by Sole legal owner / Partners / Director / Company Secretary. Only authorised signatories are permitted to authorise changes to the payment details recorded for a producer's account .
