The Isle of Man Passport Office issues non-biometric Temporary Passports to allow British citizens to undertake urgent international travel. It is issued with restricted validity for a period of 12 months.

Because of its temporary nature temporary passports may not be accepted in certain countries. Applicants should satisfy themselves before applying that the temporary passport will serve their travel needs by checking this website <https://www.gov.uk/foreign-travel-advice>

If you are satisfied that the temporary passport will meet your travel requirements, complete this application form (with countersignatory if required) and provide:

- 2x passport photographs that meet the requirements
- The correct fee

- The Passport Office accepts no responsibility for travel booked by applicants that cannot be fulfilled due to non-acceptance of the temporary passport.
- I confirm that I am unable to wait for a full validity passport (Express service – 5 working days).
