Civil Aviation Act 1982 (of Parliament)

CIVIL AVIATION (CHARGES) SCHEME 2024

Approved by Tynwald: 21 February 2024 Coming into operation in accordance with paragraph 2

The Department for Enterprise, with the consent of the Treasury¹, makes the following Scheme under section 11 of the Civil Aviation Act 1982 (of Parliament), as applied to the Island.

1 Title

This Scheme is the Civil Aviation (Charges) Scheme 2024.

2 Commencement

If approved by Tynwald, this Scheme comes into operation on 1 April 2024².

3 Interpretation

- (1) In this Scheme —
- "aircraft operator" means a person, organisation or enterprise engaged in or offering to engage in an aircraft operation;
- "certified aerodrome" means an aerodrome certified pursuant to the Civil Aviation (Aerodromes) Order 2022³;
- "cyber security" means the protection of information systems (hardware, software and associated infrastructure), the data on them, and the services they provide, from intentional or accidental unauthorised access, harm or misuse;
- "directed aerodrome" means an aerodrome directed pursuant to the Aviation Security Act 1982 as applied to the Island⁴;

- "the Department" means the Department for Enterprise;
- "FANS" means Future Air Navigation System;
- "fleet of aircraft" means multiple aircraft of the same type under the management and control of the same aircraft operator;
- "formal enforcement" means any regulatory activity that is carried out in order to seek to remedy a breach, or suspected or potential breach, of rules applicable to civil aviation;
- "IDERA" means Irrevocable De-Registration and Export Request Authorisation;
- "IOMAR" means Isle of Man Aircraft Registry;
- "MTOM" means Maximum take-off mass;
- "MTOM/MLM" means Maximum take-off mass/Maximum landing mass;
- "PBCS" means Performance Based Communication and Surveillance;
- "regulated agent" means an entity that ensures security controls in respect of cargo or mail;
- **"RNP AR APCH"** means Required Navigation Performance Authorisation Required Approach;
- "surveillance" means the activities through which the Department proactively verifies through inspections and audits that aviation licence, certificate, authorisation or approval holders continue to meet the established requirements and function at the level of competency and safety required.
- (2) Any expression which is used in this Scheme which is defined in -
 - (a) the Air Navigation (Isle of Man) Order 2015⁵;
 - (b) any instrument applied to the Isle of Man under section 11 or 11A of the Airports and Civil Aviation Act 19876; or
 - (c) any instrument made under section 11B of the Airports and Civil Aviation Act 1987,

has the same meaning given in the relevant instrument.

4 Charges

- (1) For the performance of any function of the Department specified in column 1 of the Schedule, payment of the corresponding charge in column 2 must be made to the Department.
- (2) The Department may require that a charge specified under paragraph (1) shall be paid to the Department at the time of application for the function or on receipt of an invoice.

5 Revocation

The Civil Aviation (Charges) Scheme 2023⁷ is revoked.

6 Transitional provision

Despite the revocation referred to in paragraph 5, the Civil Aviation (Charges) Scheme 2023 continues to apply to the performance of any function specified in column 1 of the Schedule where the application for the function was received by the Department before 1 April 2024 but has not been disposed of before that date.


