



## APPLICATIONS, DECISIONS AND NOTICES

The Road Transport Act 2001 ("the Act") and the Road Transport Regulations 2018 require the Road Transport Licensing Committee ("the RTLC" or "the Committee") to publish details of applications, meetings and decisions.

### OBJECTIONS

The Act provides for the RTLC to consider objections to applications in certain circumstances. Any person considering submitting an objection should first read the "Note on the submission by members of the public of objections to applications made to the RTLC" ("the Note") which is published in the "Downloadable Documents" section on front page of the [RTLC website](http://www.gov.im/rtlc).

The Note sets out the procedure for submitting an objection, including the circumstances in which the RTLC is able to consider objections. Please be aware that the RTLC has no power to consider objections outside of the circumstances outlined in the Note.

## NOTICES

### OPERATING CENTRES - TOWN AND COUNTRY PLANNING ACT 1999 ("the 1999 Act") AND ROAD TRANSPORT REGULATIONS 2018

The RTLC continues to remind all existing operators that the period of grace to ensure that all operating centres comply with the above legislation expired on 31<sup>st</sup> December 2023.

It is therefore important to recognise that, from 1<sup>st</sup> January 2024, operators whose operating centres do not comply with the 1999 Act cannot legally operate any goods vehicles with a maximum laden weight of over 3,500kg. Should any operators choose not to comply with this they would be committing an offence.

## APPLICATIONS

### 1. JRC Groundworks Ltd – Variation of an Operator Registration

The applicant wishes to vary an Operator Registration through the addition of the right to operate two goods vehicles and the addition of an operating centre.

The registered address is identified in the application as 14 Reayrt Ny Cashtal, Castletown.

The operating centre is identified in the application as Old Auldyn Construction Yard, Peel Road, Braddan.

The applicant has obtained confirmation that its operating centre complies with the 1999 Act.

The applicant currently has approval to operate one goods vehicle.

2. Manx Waste Solutions Limited – Variation of an Operator Registration

The applicant wishes to vary an Operator Registration through a change in registered address.

The registered address is identified in the application as Ca' D' Zan, 5 The Downs, Union Mills.

The applicant currently has approval to operate two goods vehicles.

To apply for a new Operator Licence through the addition of the right to operate three goods vehicles and three semi-trailers.

8. A. V. Craine & Sons Ltd - Variation of an Operator Registration

To vary its Operator Registration through a change in registered address.

The new registered address was identified as Unit 5, Tromode Estate, Carrs Lane, Tromode.

**The application was approved.**

9. Robert Jones T/A Swept Clean Road Sweeping Services – New Operator Registration

To register as a new operator through the addition of the right to operate one goods vehicle.

**The application was approved.**
