# 110/14 AGENDA FOR CHANGE MID-TERM REPORT

The Chief Officer Group ("the Group") received a presentation from the Director of Change and Reform in regard to an updated draft of the Council of Ministers' midterm report on the Agenda for Change, entitled "Securing a Sustainable Future for our Island".

During discussion, the Group provided further feedback on the report. The Group also noted that the report would be finalised, and subject to Council's agreement it would be laid before the November 2014 sitting of Tynwald.

# 111/14 ELECTRONIC TRANSACTIONS ACT 2000 – ENABLING THE GOVERNMENT DIGITAL AGENDA

COG Paper 013/14

The Chief Executive, Department of Economic Development presented a paper to the Group which proposed that the present temporary exemption that applies to the IoM Government and other public bodies in relation to the Electronic Transactions Act 2000 should not be renewed when it expires in April 2015. The Group noted that the paper set out the potential impact of such a decision and the opportunities it would create in accelerating the Departmental adoption of electronic communications in line with the original intent of the legislation.

The Group noted that this would be seen as a key enabler in moving towards the Island's Vision 2020 activities for a transformed Public Service which would be focussed primarily on customer needs and the Government's broader Digital Agenda.

Following detailed discussion, the Group agreed the recommendations as set out in the paper.

# 112/14 PROPOSAL TO OFFER VOLUNTARY REDUNDANCY TO CIVIL SERVICE SEO GRADES AND EQUIVALENT ACROSS IOM GOVERNMENT

COG Paper 017/14

The Director of Human Resources Management, OHR provided a briefing on a paper which invited the Group to consider a proposal to offer voluntary redundancy to all civil servants at Senior Executive Officer ("SEO") grade or equivalent.

During discussion, the Group acknowledged that as an organisation, the IoM Government must retain the necessary skills to maintain appropriate standards of service provision, whilst ensuring that as an employer, responsible employment practices are adhered to.

However, the Group expressed concern that a "blanket approach" voluntary redundancy scheme for SEOs would not be appropriate, as it would not allow enough Departmental flexibility to take local decisions. In conclusion, the Group agreed that it would not support the recommendations contained within the paper. It was also agreed that the Chief Secretary would meet with the Executive Director of the Office of Human Resources in due course for further discussion.

# 113/14 TRAINING "AWAY-DAY" FOR DEPARTMENTAL CHIEF EXECUTIVES

Following discussion, it was agreed that a training "Away-Day" for Departmental Chief Officers would be arranged in due course.

### a) DoI asset maintenance
