COMPANIES (ANNUAL RETURN) REGULATIONS 2006

Coming into operation 16th November 2006

In exercise of the powers conferred on the Registrar of Companies by section 216(1) of the Companies Act 2006 ^(a), and all other powers enabling it in that behalf, the following Regulations are hereby made: -

Citation and Commencement

1. These Regulations may be cited as the Companies (Annual Return) Regulations 2006 and shall come into operation on the 16th November 2006.

Prescribed Form

2. The annual return of a company under Section 85 of the Act shall be in the form set out in the Schedule.
