GAMING BETTING AND LOTTERIES (AMENDMENT) ACT 2001

AN ACT to amend the *Gaming, Betting and Lotteries Act 1988* and the *Gaming (Amendment) Act 1984*.

Betting offices

1 Conduct of betting offices

- (1) [Amends section 20 of the *Gaming, Betting and Lotteries Act 1988* (“the 1988 Act”), by substituting subsection (1).]
- (2) [Amends section 20 of the *Gaming, Betting and Lotteries Act 1988* (“the 1988 Act”), by substituting subsection (2).]
- (3) [Temporary modification of section 20(1) and (2) of the *Gaming, Betting and Lotteries Act 1988* (as substituted by subsections (1) and (2) above) - spent as from 1/7/2001.]
 - (a) [Subject to subsection (5), repeals Schedule 2 to the *Gaming, Betting and Lotteries Act 1988*, and amends Schedule 5 to that Act by repealing the entry relating to section 20(1).]
 - (b) [Amends section 2 of the *Betting Offices Act 2001* by repealing the expression “(1),” in subsection (2) and by repealing subsection (4).]
- (4) Schedule 2 to the 1988 Act shall continue in force, with the substitution for paragraph 1 of the following —

“Opening hours

1. The premises shall be closed throughout Good Friday and Christmas Day.”
as if it were contained in regulations under section 20(1) of that Act, as substituted by subsection (1), and may be amended or revoked accordingly.

- (2) [Amends section 20(7) of the *Gaming, Betting and Lotteries Act 1988* by substituting the expression “subsection (6B)” for the expression “subsection (6)”.]
- (3) [Amends Schedule 5 to the *Gaming, Betting and Lotteries Act 1988* by substituting the expression “Section 20(6B)” for the expression “Section 20(7)” in column 1.]
- (4) [Temporary modification of section 20(6) and (6A) of the *Gaming, Betting and Lotteries Act 1988* (as substituted by subsection (1) of this section) - spent as from 1/7/2001.]

3 Amendments Betting Offices Act 2001

[Amends section 4(4) of the *Betting Offices Act 2001* by substituting the following for the words from “and expiring” onwards –

“and expiring –

- (i) in the case mentioned in paragraph (a), on the expiration of 3 months beginning with the commencement of this Act;
- (ii) in the case mentioned in paragraph (b), on the date on which it would have expired if this Act had not been passed.”]

*Lotteries***4 Amendments 1988 Act**

[Amends section 30(2) of the *Gaming, Betting and Lotteries Act 1988* by substituting the words “the months of November and December” for the words “the month of December”.]

5 Amendments 1988 Act

[Amends section 32(3) of the *Gaming, Betting and Lotteries Act 1988* by substituting paragraphs (h), (i) and (ia) for paragraphs (h) and (i).]

6 Amendments 1988 Act

- (1) [Amends section 32(3) of the *Gaming, Betting and Lotteries Act 1988* by substituting paragraphs (c), (ca) and (cb) for paragraph (c).]
- (2) [Amends section 32 of the *Gaming, Betting and Lotteries Act 1988* by substituting subsections (4), (4A) and (4B) for subsection (4).]

- (3) [Amends section 48(1) of the *Gaming, Betting and Lotteries Act 1988* by inserting the definition of “jackpot prize”.]

7 Amendments 1988 Act

- (1) [Amends section 48 of the *Gaming, Betting and Lotteries Act 1988* by inserting subsection (1A).]
- (2) [Amends section 47(2) of the *Gaming, Betting and Lotteries Act 1988* by substituting the expression “32(9), 33(6) and 48(1A)” for the expression “32(9) and 33(6)”.]

8 Amendments

- (1) [Inserts section 34A in the *Gaming, Betting and Lotteries Act 1988*.]
- (2) [Amends section 1 of the *Gaming, Betting and Lotteries Act 1988* by inserting subsection (2A).]
- (3) [Amends section 9(1)(b) of the *Gaming, Betting and Lotteries Act 1988* by substituting the words “the total value of all prizes and awards distributed in respect of all games played at the entertainment” for the words from “not more” to “those games”.]
- (4) [Amends section 15(1)(a)(ii) of the *Pool Betting (Isle of Man) Act 1961* by inserting the expression “,or the conditions mentioned in section 34A(a) and (b),” after the expression “section 32(2)(b), (c) and (g)”.]
 - (a) [Amends section 37(2) of the *Licensing Act 1995* by substituting paragraph (c).]
 - (b) [Amends section 80(4) of the *Licensing Act 1995* by substituting the expression “31(1), 32(3) or 34A” for the expression “31(1) or 32(3)”.]

9 Amendments 1988 Act

- (1) [Amends section 29 of the *Gaming, Betting and Lotteries Act 1988* by inserting subsection (2A).]
- (2) [Inserts sections 33A and 33B in the *Gaming, Betting and Lotteries Act 1988*.]
- (3) [Amends section 47(2) of the *Gaming, Betting and Lotteries Act 1988* by inserting the expression “, 33A(8)” after the expression “33(6)”.]

10 [Repealed]¹*Controlled machines***11 [Amendment of section 17 of *Gaming (Amendment) Act 1984*]**

[Amends section 17(1) of the *Gaming (Amendment) Act 1984* by substituting the definition of “premises”.]

12 [Repealed]²*Supplemental***13 Short title and commencement**

- (1) This Act may be cited as the Gaming, Betting and Lotteries (Amendment) Act 2001.
- (2) This Act, except section 10, shall come into operation on such day or days as the Department of Home Affairs may by order appoint.³
- (3) Section 10 shall come into operation on such day as the Treasury may by order appoint.
