

GAMING, BETTING AND LOTTERIES ACT 1988

SOCIETY LOTTERY RETURN BY A PROMOTER FOR LOTTERIES PLAYED AS GAMES (BINGO & RACE NIGHTS)

This return form shall be completed by an Isle of Man society that is registered with the Gambling Supervision Commission (GSC) as a Society Lottery under Section 33 of the Gaming, Betting and Lotteries Act 1988 (GBL) and approved to promote lotteries played as games in the Island in accordance with Section 34A of the Act.

Section 34A of the Act provides that a society lottery is not unlawful if it is played as a game and complies with such conditions as may be prescribed. These conditions are prescribed within the Bingo Nights (Prescribed Conditions) Regulations 2010 (BNR); and the Racing Nights (Prescribed Conditions) Regulations 2010 (RNR).

Section 34 of GBL requires that no later than the end of one month after the month in which the winners of prizes in a lottery are ascertained, the promoter shall deliver to the Commission a return, which has been certified by a member of an approved accounting body.

This form should be completed in conjunction with the GSC's <u>Guidance Notes for Society Lotteries</u> and the Integrity Guidance.
