#### **SUPERANNUATION ACT 1984**

#### **TEACHERS' SUPERANNUATION ORDER 2011**

Approved by Tynwald 2011

Coming into operation in accordance with article 2

The Department of Education and Children makes this Order under sections 4 and 12(2) and (3) of the Superannuation Act 1984<sup>1</sup>.

#### 1. Citation

The title of this Order is the Teachers' Superannuation Order 2011.

#### 2. Commencement

If approved by Tynwald, this Order —

- (a) so far as it relates to any of the applied regulations, is deemed to have come into operation on the date on which those regulations came into force in England and Wales;
- (b) otherwise, comes into operation on the 1st January 2011.

## 3. Interpretation

In these Regulations "the applied regulations" means the regulations specified in Schedule 1, being regulations made under section 9 and (so far as it relates to teachers) section 24 of the Superannuation Act 1972 (an Act of Parliament)<sup>2</sup>.

## 4. Application of Regulations

The applied regulations shall apply to the Island subject to the modifications specified in Schedule 2.

## 5. Transitional provision

- (1) Where a person is entitled or required to make any election under any provision of the applied regulations specified in Schedule 3, that person may make such an election within 3 months beginning with the date specified in column 4 of that Schedule; and any election so made shall have effect as if made in accordance with the provision in question and within the time thereby allowed.
- (2) Nothing in this article affects any election made in accordance with any provision specified in Schedule 3 and within the time thereby allowed.

#### 6. Amendment of 2007 Order

The Teachers' Superannuation Order 2007<sup>1</sup> is amended in accordance with Schedule 4.

#### **EXPLANATORY NOTE**

(This note is not part of the Order.)

This Order applies to the Isle of Man with modifications the Teachers' Pensions Regulations 2010, which replaced the Teachers' Pensions Regulations 1997 in England and Wales. The Order replaces the Teachers' Superannuation Order 2007 (SD 22/07) so far as it applied the 1997 Regulations to the Isle of Man.

The Order provides for the applied regulations to have retrospective effect, as authorised by section 12(2) of the Superannuation Act 1984.
