Report on Committees and Quasi-Autonomous Entities

Foreword by the Hon John Shimmin MHK, Minister for Policy and Reform

To: The Hon Clare Christian, OBE MLC, President of Tynwald and the Honourable Council and Keys in Tynwald assembled.

The Council of Ministers has welcomed to opportunity to undertake a review of Government Committees and quasi-autonomous entities.

I was very pleased to second the motion at the January 2016 sitting of Tynwald in respect of this Review. It is recognised that there is a need to consolidate the significant amount of work which has already been undertaken to produce a comprehensive record of the various committees and organisations which support the work of Government.

The recommendations contained within this report seek to enhance the current arrangements in place and whilst it is accepted that there is further work to be done, what has been produced represents a solid basis to take forward into the new administration following the general election in September 2016.

1. Introduction

1.1 At the January 2016 sitting of Tynwald the following motion was carried:

"That Tynwald calls on the Council of Ministers to review the existence, purpose, nature, membership, functioning and cost of all committees and quasi-autonomous entities in which any Department, Board or Office of the Isle of Man Government has a role considering in particular the relationship of each committee or entity with (a) Tynwald and its policy review committees and (b) the complaints process; and to report by July 2016 with recommendations and an action plan."

1.2 Terms of Reference

The requirements of the Tynwald motion provided the basis for the Terms of Reference for the Review which was as follows:

- a. Review the existence, purpose, nature, membership, functioning and cost of all committees and quasi-autonomous entities in which any Department, Board or Office of the Isle of Man Government has a role;
- b. Consider the relationship of each committee or entity with:
 - Tynwald and its Policy Review Committees;
 - the complaints process; and
- c. Report with recommendations and an action plan to the July 2016 sitting of Tynwald.

1.3 Methodology

At the August 2015 sitting of Tynwald the Chief Minister, in his response to a written parliamentary question from Mrs K J Beecroft MHK defined Government Committees as:

'A group of people appointed either by statute or by delegation to perform a specific function in relation to the operation of Government.....'

In 2012 a cohort undertaking the Government's Senior Management Development Programme, tasked as part of an action learning set with conducting a review of organisations which undertake quasi non-governmental roles, defined Quangos as:

'A quasi-autonomous non-governmental organisation that is not defined in the Government Departments Act 1987 or the Statutory Boards Act 1987, but is still funded by the taxpayer, although not controlled directly by central Government.'

For clarity, organisations defined as Quangos include, but are not limited to:

- Tribunals
- Committees
- Boards
- Authorities
- Commissions

- Advisory Bodies
- Offices

Taking into account the definitions above, for the purposes of this Review the following overarching criteria was established to determine the organisations which should be included:

- Non-statutory committees;
- Statutory committees (including any which have yet to be formed);
- Quasi-autonomous organisations ("Quangos"); and
- Any other bodies which do not fall into any of the above categories

Chief Officers from all Departments, Offices and Statutory Boards ("Departments") were asked to provide details of the organisations within their Department which fell into the criteria above.

Based on those submissions a draft list of Quangos and Government Committees has been produced [attached at appendix 1].

2. Findings

2.1 Number of Quangos and Government Committees

The Review identified 88 organisations as being relevant. It should be noted that whilst all reasonable endeavours have been taken to produce a comprehensive list based on the data available, further validation of the organisations included will need to be undertaken to ensure completeness.

2.2 Public Register

It is apparent that each time the matter of Quangos, Government Committees and similar organisations is raised an updated list is produced afresh albeit compiled from previous iterations and subject to the criteria relevant to each particular request. Going forward, for clarity, there is a need for a definitive register to be produced, published, reviewed and updated on a regular basis.

2.3 Corporate Governance

Corporate governance is the system by which Government directs and controls its functions.

The Isle of Man Corporate Governance Principles and the Code of Conduct apply to all 'designated bodies' and 'Departments of Government' within the meaning of the Treasury Act 1985. The three fundamental principles of corporate governance are openness, integrity and accountability.

The Statement on Internal Control ("SIC") is a statutory requirement and forms a part of the Government's published financial statements. The key governance submission from Departments, which forms part of the annual SIC process, is an 'Assurance Certificate'.

The Assurance Certificate is predominantly comprised of the responses to Self-Review Questionnaires completed by each Division within a Department and primarily relates to the operational controls and the management of risks in respect of:

- Business Continuity
- Performance Management
- Finance and Financial Compliance
- Procurement
- Information Management
- Value for Money
- Human Resources
- Change Management
- Health and Safety
- Environment
- General Corporate Governance

There are no specific arrangements within the SIC process in relation to Quangos or Government Committees; therefore there is no certainty that a consistent approach to corporate governance is being taken, although any identified risks in relation to executive functions would normally be covered.

A consistent approach across Government in respect of a corporate governance framework should be in place and apply equally to all Quangos and Government Committees.

A corporate governance framework for Quangos and Government Committees should be based on the following considerations:

- The statutory basis under which the organisation has been established should be clear.
- All organisations, irrespective their size and extent of their remit should be underpinned by an agreed Terms of Reference which provides clarity on the purpose, scope and structure.
- Clarity in respect of responsibilities, powers and term of office of the Chair and members.
- The Chair and members must to be aware of their legal responsibilities, the legal implications of their decisions, the extent and limitations of their powers and their liability in law for the effect of their actions.
- Clarity in respect of the legal relationship between the organisation and the sponsoring Department.
- Open, clear, transparent and consistent procedures for the appointment and induction of members.
- Annual reporting proportionate to the size of the organisation and its remit.
- Regular reviews of the purpose, scope, structure, cost and value for money of the organisation.

2.3 Complaints Process

The responses received from Departments indicate that whilst there are various processes and procedures in place at an operational level for complaints to be made and resolved it is unclear how such feedback is subsequently acted upon.

Beyond the resolution of the complaint, the recording and classifying [by commonality, frequency, severity etc.] of complaint data provides management information which is essential for policy development, strategic decision making and continuous improvement. The publication of complaint data improves openness and transparency and allows a greater degree of accountability in respect of the effectiveness of the organisation.

The actions resulting from an analysis of complaint data should form part of the internal planning and performance reporting framework of the organisation and be summarised as part of an annual reporting process.

2.4 Cost of Quangos and Government Committees

Whilst in some cases the payments made under the Payment of Members' Expenses Act 1989 or through any specific budget allocated to the Quango or Government Committee have been identified [see appendix 1] a further piece of work, perhaps as part of a more in depth review of each individual organisation, needs to be undertaken to establish the nature and extent of the costs.

2.5 Tynwald – Policy Review Committees

Based on the available information provided, the majority of organisations do not have a direct link to Tynwald or its Policy Review Committees. In some cases an organisation does have an obligation to submit annual report to Tynwald, however this is dependent upon the particular remit or constitution rather than a standing or statutory requirement for all organisations to do so.

Organisations can, have and will continue to be called upon, albeit on an ad hoc basis, to give evidence to Tynwald's Policy Review Committees.

Whilst a consistent and continuous approach to scrutiny is required this must be proportionate to the size of the organisation and its remit.

Scrutiny options to consider:

- Establish the link between the remit of the organisation and Government priorities and set and monitor the delivery of objectives on that basis, via the sponsoring Department (where appropriate).
- Ensure a 'clear line of sight' exists between the organisation and the sponsoring Department in order to ensure appropriate oversight and to standardise and streamline performance reporting.
- Publication, via Tynwald, of an annual report – potentially using one set of classifications to 'group' organisations to facilitate consolidated and standardised reporting.

3. Next steps

In conjunction with Departments, further work is required to validate the list of Quangos and Government Committees prior to publishing the definitive register. The validation will broadly require:

- Direct input from all Departments along with the organisations themselves.
- A definitive criteria to be agreed in respect of the organisations to be included on/excluded from the register
- Agreement on the composition of the register and the subsequent verification of each constituent part.
- Agreement on the process for, and frequency of, reviews to ensure ongoing validation and verification takes place.

There is a need to provide assurance on an ongoing basis that governance arrangements are in place, are being consistently applied and are effective across all such organisations. It is the intention to consult the Audit Advisory Division of the Treasury to identify the most appropriate mechanism to achieve this.

There is also a need to undertake a review of the purpose, scope, structure and cost of each organisation to ensure that the organisation, as constituted, remain the most appropriate vehicle to deliver its remit and is delivering value for money.

4. Recommendations

1. The Cabinet Office, in conjunction with Departments, validate the list of Quangos and Government Committees prior to a definitive register being published;
2. The Cabinet Office maintains the public register of Quangos and Government Committees;
3. That each sponsoring Department undertakes a review of the purpose, scope, structure, cost and value for money of each organisation to ensure that the organisation, as constituted, remains the most appropriate vehicle to deliver the remit;
4. That the Cabinet Office be advised of the outcome of the Departmental reviews;
5. In conjunction with the Audit Advisory Division of the Treasury, the Cabinet Office coordinates a review of the current corporate governance arrangements for Quangos and Government Committees with a view to [the Cabinet Office] subsequently implementing a standard framework which can be applied consistently across all such organisations; and
6. An Assurance Certification process for each Quango and Government Committee, to validate the governance arrangements, be implemented and monitored to ensure the arrangements in place are appropriate and remain so.
